- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 Petition: Mr Jess presented a petition from certain citizens of Australia praying that this House give earnest consideration, during Human Rights Year, to the crisis in education in Australia.

Petition received.

- 3 QUESTIONS: Questions without notice were asked.
- 4 GRIEVANCE DEBATE: Pursuant to the provisions of standing order 106, the order of the day having been read—

Question proposed—That grievances be noted.

Debate ensued.

It being fifteen minutes to one o'clock p.m., the debate was interrupted in accordance with standing order 106.

Ouestion—That grievances be noted—put and passed.

- 5 POSTPONEMENT OF NOTICE: Ordered—That notice No. 1, government business, be postponed until a later hour this day.
- 6 AGED PERSONS HOMES BILL 1969: Mr Wentworth (Minister for Social Services), pursuant to notice, presented a Bill for an Act to amend the *Aged Persons Homes Act* 1954–1967, and for other purposes.

Bill read a first time.

Mr Wentworth moved—That the Bill be now read a second time.

Debate adjourned (Mr C. R. Cameron), and the resumption of the debate made an order of the day for the next sitting.

- 7 CUSTOMS TARIFF PROPOSALS Nos. 8 to 11 (1969): Mr Nixon (Minister representing the Minister for Customs and Excise) moved Customs Tariff Proposals Nos. 8, 9, 10 and 11 (1969).
 - Debate adjourned (Mr Barnard—Deputy Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

9 DEFENCE (PARLIAMENTARY CANDIDATES) BILL 1969: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Bill, by leave, taken as a whole.

On the motion of Mr Fairhall (Minister for Defence), the following amendment was made: Clause 6, page 3, after sub-clause (2.) insert the following sub-clause:

"(3.) The Minister may, for the purposes of sub-section (1.) of this section, treat the result of an election as being certain if, at the expiration of thirty days after the return of the writ relating to the election, the validity of the election has not been disputed in accordance with law and the Minister has no reason to believe that it will be so disputed."

Bill, as amended, agreed to.

Bill to be reported with an amendment.

The House resumed; Mr Lucock reported accordingly.

On the motion of Mr Fairhall, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

10 Defence Forces Retirement Benefits Bill 1969: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

Message from the Governor-General: Mr Speaker announced the receipt of message No. 145, dated 22 May 1969, from His Excellency the Governor-General recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Fairhall (Minister for Defence), the Bill was read a third time.

11 MEAT INDUSTRY BILL 1968: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Clauses 1 and 2, by leave, taken together, and agreed to.

Clause 3—

Mr Patterson moved the following amendment: Page 1, omit sub-clause (1.), insert the following sub-clause:

"(1.) Section 8 of the Principal Act is amended—

- (a) by omitting from sub-section (1.) the word 'nine' and inserting in its stead the word 'twelve';
- (b) by omitting from paragraph (b) of sub-section (1.) the word 'five' and inserting in its stead the word 'six'; and

- (c) by adding at the end of sub-section (1.) the following paragraphs:—
 - '(e) one member to represent publicly owned abattoirs and freezing works which deal with meat or meat products for export from Australia; and
 - (f) one member to represent employees engaged in the slaughter and preparation of meat or meat products for export.".

Question—That the sub-clause proposed to be omitted stand part of the clause—put. The committee divided (the Chairman, Mr Lucock, in the Chair)—
