- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. The Acting Speaker (Mr Lucock) took the Chair, and read Prayers.
 - 2 PETITION: Mr Arthur presented a petition from certain electors of the Commonwealth praying that adequate refund for physiotherapy treatment ordered by a registered medical practitioner may be included in the Commonwealth benefits scheme in like manner to other medical benefits.
Petition received and read.
 - 3 MINISTERIAL ARRANGEMENTS: Mr Gorton (Prime Minister) informed the House that, during the forthcoming absence abroad of Mr Freeth (Minister for External Affairs), Mr Fairhall (Minister for Defence) would act as Minister for External Affairs.
 - 4 QUESTIONS: Questions without notice were asked.
 - 5 PAPERS: The following papers were presented, by command of His Excellency the Governor-General:

 - 7 POSTPONEMENT OF NOTICES: Ordered—That notices Nos. 1 and 2, government business, be postponed until a later hour this day.
 - 8 LOAN (SWISS FRANCS) BILL 1969: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
Debate resumed.
Question—put and passed—Bill read a second time.
Leave granted for third reading to be moved forthwith.
On the motion of Mr Bury (Minister for Labour and National Service), the Bill was read a third time.

- 9 **LOAN (CANADIAN DOLLARS) BILL 1969:** The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
Question—put and passed—Bill read a second time.
Leave granted for third reading to be moved forthwith.
On the motion of Mr Bury (Minister for Labour and National Service), the Bill was read a third time.
- 10 **TASMANIA GRANT (CRESSY-LONGFORD IRRIGATION WORKS) BILL 1969:** The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
Debate resumed.
Question—put and passed—Bill read a second time.
Message from the Governor-General: Mr Acting Speaker announced the receipt of message No. 156, dated 9 September 1969, from His Excellency the Governor-General recommending an appropriation of revenue for the purposes of the Bill.
Leave granted for third reading to be moved forthwith.
On the motion of Mr Fairbairn (Minister for National Development), the Bill was read a third time.
- 11 **APPROPRIATION BILL (No. 1) 1969–70:** The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.

- 13 **PUBLIC WORKS COMMITTEE—REFERENCE OF WORKS—HIGH SCHOOLS, CASUARINA (DARWIN) AND ALICE SPRINGS, N.T.—STATEMENTS BY MEMBERS:** Mr Chaney (Chairman), by leave, made a statement relating to the reference to the Parliamentary Standing Committee on Public Works of the proposal to build high schools at Casuarina (Darwin) and at Alice Springs.
Mr Patterson and Mr Calder, by leave, also made statements with reference to the matter.

- 14 APPROPRIATION BILL (NO. 1) 1969-70: The House, according to order, again resolved itself into a committee of the whole for the further consideration of the Bill.

- 15 STATES GRANTS (ABORIGINAL ADVANCEMENT) BILL 1969: Mr Wentworth (Minister in charge of Aboriginal Affairs), pursuant to notice, presented a Bill for an Act to grant Financial Assistance to the States in connexion with the Welfare and Advancement of the Aboriginal People of Australia.

Bill read a first time.

Mr Wentworth moved—That the Bill be now read a second time.

Debate adjourned (Mr Stewart), and the resumption of the debate made an order of the day for the next sitting.

- 16 STATES GRANTS (ABORIGINAL ADVANCEMENT) BILL (NO. 2) 1969: Mr Wentworth (Minister in charge of Aboriginal Affairs), pursuant to notice, presented a Bill for an Act to amend section 4 of the *States Grants (Aboriginal Advancement) Act 1968*.

Bill read a first time.

Mr Wentworth moved—That the Bill be now read a second time.

Debate adjourned (Mr Stewart), and the resumption of the debate made an order of the day for the next sitting.
