- 1 The House met, at two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 PETITIONS: Mr J. R. Fraser presented a petition from certain citizens of the Commonwealth praying for the immediate release of Gordon Riesenlieter and all those imprisoned as a result of individual conscience, and the immediate repeal of the National Service Act.

Petition received and read.

Mr Dobie presented a petition from certain citizens of Australia praying that this House take immediate steps to abolish the means test for all people who have reached retiring age or who otherwise qualify for social service benefits or pensions.

7 MELBOURNE (TULLAMARINE) AIRPORT—CUSTOMS BUILDING AND INCINERATOR—APPROVAL OF WORK: Mr Kelly (Minister representing the Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1913–1966, it is expedient to carry out the following proposed works which were referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to this House: Melbourne (Tullamarine) Airport— Construction of Customs Building and Incinerator.

Debate ensued.

Question—put and passed.

8 AIR NAVIGATION (CHARGES) BILL 1969: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed.

Question-put and passed-Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Clauses 1 and 2, by leave, taken together, and agreed to. Clause 3-

Mr C. K. Jones moved the following amendment: Page 2, sub-clause (1.), paragraph (*a*), after sub-paragraph (1A.) proposed to be inserted in paragraph 7 of the First Schedule to the Principal Act insert the following sub-paragraph:

"(1B.) A charge imposed by the preceding sub-paragraphs shall be increased by five hundred per cent in respect of pure jet-powered aircraft taking-off or landing at Kingsford-Smith (Sydney), Essendon, Tullamarine, Brisbane, and Adelaide between the hours of 11 p.m. on any day and 6 a.m. on the following day.".

Debate ensued.

Question-That the amendment be agreed to-put.

Clause agreed to. Title agreed to. Bill to be reported without amendment.

The House resumed; Mr Lucock reported accordingly.

- On the motion of Mr Swartz (Minister for Civil Aviation), the House adopted the report, and, by leave, the Bill was read a third time.
- 9 SOCIAL SERVICES BILL 1969: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Suspension of standing orders—Extended time for speech: Mr Wentworth (Minister for Social Services) moved, by leave—That so much of the standing orders be suspended as would prevent Mr Daly speaking without limitation of time.

Question-put and passed.

- Debate resumed by Mr Daly who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "whilst not opposing the provisions of the Bill, the House condemns the Government because it has failed to—
 - (a) increase adequately rates of all pensions and social service benefits to meet the increased cost of living;
 - (b) investigate and deal with the real areas of need and poverty;
 - (c) provide an equitable and just basis for regular review of social service benefits to maintain their purchasing power;
 - (d) eliminate injustices of discrimination between pensioners and the sick and the needy;
 - (e) provide 'fringe benefits' for all pensioners;
 - (f) give effect to the 1949 election policy of the Liberal-Country Party to abolish the means test; and
 - (g) make benefits retrospective to 1 July 1969".
- Debate adjourned (Mr Lee), and the resumption of the debate made an order of the day for a later hour this day.
- 10 DEFENCE FORCES RETIREMENT BENEFITS FUND—DISTRIBUTION OF SURPLUS—MINISTERIAL STATEMENT: Mr McMahon (Treasurer), by leave, made a ministerial statement with reference to the proposed distribution by the Defence Forces Retirement Benefits Board of surplus assets to eligible pensioners and contributors.
 - Mr Whitlam (Leader of the Opposition) and Mr Stokes, by leave, also made statements with reference to the matter.
- 11 OVERSEAS INVESTMENT IN AUSTRALIA—MINISTERIAL STATEMENT: Mr Gorton (Prime Minister), by leave, made a ministerial statement with reference to overseas investment in Australia.
 - Mr Whitlam (Leader of the Opposition), Mr McMahon (Treasurer) and Mr Crean, by leave, also made statements with reference to the matter.

- 13 FISHING INDUSTRY RESEARCH BILL 1969: Mr Anthony (Minister for Primary Industry), by leave, presented a Bill for an Act to establish a Fishing Industry Research Trust Account, and for purposes connected therewith.
 - Bill read a first time.

Mr Anthony moved—That the Bill be now read a second time.

Debate adjourned (Mr Patterson), and the resumption of the debate made an order of the day for the next sitting.

14 AIRLINE EQUIPMENT (LOAN GUARANTEE) BILL 1969: Mr Swartz (Minister for Civil Aviation), by leave, presented a Bill for an Act relating to the provision of certain Equipment for a Domestic Airline.

Bill read a first time.

Mr Swartz moved—That the Bill be now read a second time.

Debate adjourned (Mr C. K. Jones), and the resumption of the debate made an order of the day for the next sitting.

15 LOANS (AUSTRALIAN NATIONAL AIRLINES COMMISSION) BILL 1969: Mr Swartz (Minister assisting the Treasurer), by leave, presented a Bill for an Act to authorize the Raising and Expenditure of a certain sum of Money to be made available to the Australian National Airlines Commission, and for purposes connected therewith.

Bill read a first time.

Mr Swartz moved—That the Bill be now read a second time.

Debate adjourned (Mr C. K. Jones), and the resumption of the debate made an order of the day for the next sitting.

16 NORTHERN TERRITORY (ADMINISTRATION) BILL 1969: Mr Nixon (Minister for the Interior), by leave, presented a Bill for an Act to amend the Northern Territory (Administration) Act 1910–1968 in connexion with the Aborigines Benefits Trust Fund. Bill read a first time.

Mr Nixon moved—That the Bill be now read a second time.

Debate adjourned (Mr Stewart), and the resumption of the debate made an order of the day for the next sitting.

17 STATES GRANTS (ADVANCED EDUCATION) BILL 1969: Mr J. M. Fraser (Minister for Education and Science), by leave, presented a Bill for an Act relating to the grant of Financial Assistance to the States in connexion with Advanced Education. Bill read a first time.

Mr Fraser moved-That the Bill be now read a second time.

Debate adjourned (Mr Stewart), and the resumption of the debate made an order of the day for the next sitting.

18 STATES GRANTS (INDEPENDENT SCHOOLS) BILL 1969: Mr J. M. Fraser (Minister for Education and Science), by leave, presented a Bill for an Act to grant Financial Assistance to the States in relation to Independent Schools.

Bill read a first time.

Mr Fraser moved—That the Bill be now read a second time.

Debate adjourned (Mr Whitlam—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

19 SOCIAL SERVICES BILL 1969: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Daly, viz.—That all words after "That" be omitted with a view to inserting the following words in place thereof: "whilst not opposing the provisions of the Bill, the House condemns the Government because it has failed to—

- (a) increase adequately rates of all pensions and social service benefits to meet the increased cost of living;
- (b) investigate and deal with the real areas of need and poverty;
- (c) provide an equitable and just basis for regular review of social service benefits to maintain their purchasing power;
- (d) eliminate injustices of discrimination between pensioners and the sick and the needy;
- (e) provide 'fringe benefits' for all pensioners;
- (f) give effect to the 1949 election policy of the Liberal-Country Party to abolish the means test; and
