- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petition: Mr Hurford presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) a joint Commonwealth-State inquiry into inequalities in Australian education, (2) the immediate financing of special programmes for low income earners and others and (3) the provision of preschool opportunities for all children.

Petition received.

Wine Overseas Marketing Act—Australian Wine Board—Forty-first Annual Report, for year 1968-69, together with statement by Minister regarding the operation of the Act.

- 7 PAPUA AND NEW GUINEA HOUSE OF ASSEMBLY—MINISTERIAL MEMBERS—MINISTERIAL STATEMENT AND PAPER—MOTION TO TAKE NOTE OF PAPERS: Mr Barnes (Minister for External Territories), by leave, made a ministerial statement informing the House of increased powers for Ministerial Members of the Papua and New Guinea House of Assembly, and, by command of His Excellency the Governor-General, presented the following papers:

Papua and New Guinea-

House of Assembly—Ministerial Members—Ministerial statement, 4 March 1970.

Approved arrangements for Ministerial Members made under section 25 of the Papua and New Guinea Act, and notes on conduct of holders of ministerial office.

Mr Drury, Mr G. D. Erwin, Mr Fox and Mr Giles had been appointed by the Prime Minister. Mr Birrell, Mr Bryant, Mr Duthie and Mr McIvor had been appointed by the Leader of the Opposition in this House and Mr Barnard (Deputy Leader of the Opposition) had been appointed jointly by the Leaders of the Opposition in the Senate and the House of Representatives.

In accordance with paragraph (3) of the resolution of appointment of the committee, the Prime Minister had appointed Mr Snedden (Leader of the House) and the Leader of the Country Party in the House of Representatives had appointed Mr Nixon (Minister for the Interior) to attend the committee when they are unable to be present.

Cameron had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The unjust Commonwealth Government decisions and submissions on wage and salary rates, equal pay, and employment standards for Commonwealth employees".

The proposed discussion having received the necessary support— Mr Cameron addressed the House.

Mr Bowen moved—That the Bill be now read a second time.

29 REPATRIATION BILL 1970: Mr Holten (Minister for Repatriation), pursuant to notice, presented a Bill for an Act to amend the *Repatriation Act* 1920-1969 in relation to Service Pensions Payable to certain Married Persons suffering Illness or Infirmity, and to appropriate the Consolidated Revenue Fund for the purpose of certain Payments resulting from the Amendments.

Bill read a first time.

Mr Holten moved—That the Bill be now read a second time.

Debate adjourned (Mr Stewart), and the resumption of the debate made an order of the day for the next sitting.
