# THURSDAY, 19 MARCH 1970

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Peritions: Mr Wentworth (Minister for Social Services) presented a petition from certain residents of New South Wales praying that the export of all kangaroo products be banned immediately.
  - Mr Jacobi presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) a joint Commonwealth-State inquiry into inequalities in Australian education, (2) the immediate financing of special programmes for low income earners and others and (3) the provision of pre-school opportunities for all children.
  - Mr K. M. K. Cairns presented a petition from certain electors of the Commonwealth praying that the House take urgent measures for greatly increased defence, with absolute priority to the acquisition of the British Far Eastern Carrier Fleet, and the establishment of a large scale aircraft manufacturing industry.

Petitions severally received and read.

- 3 OUESTIONS: Questions without notice were asked.
- 4 Papers—Ministerial statement: The following papers were presented, by command of His Excellency the Governor-General:

- Mr Hughes (Attorney-General), by leave, made a ministerial statement in connection with the papers.
- Mr Whitlam (Leader of the Opposition) and Mr Connor, by leave, also made statements on the same subject.
- 5 CONCESSION FARES FOR PENSIONERS ON COMMONWEALTH RAILWAYS—MINISTERIAL STATE-MENT: Mr Sinclair (Minister for Shipping and Transport), by leave, made a ministerial statement informing the House of concession fares to be granted to pensioners travelling on Commonwealth Railways.
  - Mr Jones and Mr Daly, by leave, also made statements with reference to the matter.
- 6 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—URBAN LAND PRICES: Mr Speaker informed the House that Mr Uren had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The uncontrolled spiralling price of urban land particularly in all Australian capital and provincial cities".

The proposed discussion having received the necessary support—

Mr Uren addressed the House.

11 STATES GRANTS (TEACHERS COLLEGES) BILL 1970: Mr N. H. Bowen (Minister for Education and Science), pursuant to notice, presented a Bill for an Act to grant Financial Assistance to the States for the purposes of Building Projects in connexion with Teachers Colleges.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Thank you for your Address in Reply which you have just presented to me.

It will be my pleasure and my duty to convey to Her Most Gracious Majesty The Queen at once the Message of Loyalty from the House of Representatives of the Commonwealth of Australia, to which the Address gives expression.

Mr Bury moved—That the Bill be now read a second time.

26 Anglo-Australian Telescope Agreement Bill (No. 2) 1970: Mr Bury (Treasurer), pursuant to notice, presented a Bill for an Act to amend the Anglo-Australian Telescope Agreement Act 1970.

Bill read a first time.

Mr Bury moved-That the Bill be now read a second time.

Debate adjourned (Mr C. R. Cameron), and the resumption of the debate made an order of the day for the next sitting.

- 27 FOREIGN AFFAIRS—PROPOSED JOINT COMMITTEE: Mr McMahon (Minister for External Affairs) moved, by leave—
  - (1) That a joint committee be appointed to consider foreign affairs generally and to report to the Minister for External Affairs upon such matters as are referred to it by the Minister.
  - (2) That the committee consist of eight Members of the House of Representatives appointed by the Prime Minister, six Members of the House of Representatives appointed by the Leader of the Opposition in the House of Representatives, four Senators appointed by the Leader of the Government in the Senate, three Senators appointed by the Leader of the Opposition in the Senate and one Senator appointed by the Leader of the Australian Democratic Labor Party in the Senate.
  - (3) That every appointment of a member of the committee be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
  - (4) That the Minister for External Affairs shall make available to the committee information within such categories or on such conditions as he may consider desirable.
  - (5) That the members of the committee shall hold office as a joint committee until the House of Representatives expires by dissolution or effluxion of time.
  - (6) That the committee shall have power to appoint sub-committees consisting of four or more of its members; and to refer to any such sub-committees any of the matters which the committee is empowered to consider.
  - (7) That the committee or any sub-committee shall have power to adjourn from place to place and to sit during any recess or adjournment of the Parliament and during the sittings of either House of the Parliament.
  - (8) That the committee and its sub-committees shall sit *in camera* and their proceedings shall be secret unless the Minister at the request of the committee otherwise directs.
  - (9) That seven members of the committee constitute a quorum of the committee and three members of a sub-committee shall constitute a quorum of that sub-committee.
  - (10) That (a) on every occasion when the committee reports to the Minister on any matter pursuant to his request the committee shall inform the Parliament of the fact that it has so reported, otherwise the proceedings of the committee shall not be reported to either House;
    - (b) the Minister shall forward a copy of any such report as he has requested to the Leader of the Opposition for his confidential information;
    - (c) the committee may communicate with the Minister but all communications with the Minister and the fact of any such communication shall be confidential to the committee and the Minister.

- (11) That the committee shall have power to invite persons to give evidence before the committee.
- (12) That with the consent of the Minister for External Affairs, the committee shall have power to call for official papers or records.
- (13) That all written and oral evidence submitted to or received by the committee in camera shall be confidential to the committee and the Minister.
- (14) That any member of the committee have power to add a protest or dissent to any report, but the protest or dissent may not introduce new matter not referred to in the main report.
- (15) That the committee have power to consider the minutes of evidence and records of the Joint Committee on Foreign Affairs appointed in the previous Parliament relating to any matter on which that committee had not completed its consideration.
- (16) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
- (17) That a message be sent to the Senate acquainting it of this resolution and requesting that it concur and take action accordingly.

Mr Beazley moved, as an amendment—That the following words be added at the end of paragraph (1): "and to report to the Parliament on such matters as are referred to it by either House of the Parliament".
