WEDNESDAY, 22 APRIL 1970

- 1 The House met, at two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Hansen presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) a joint Commonwealth-State inquiry into inequalities in Australian education, (2) the immediate financing of special programmes for low income earners and others and (3) the provision of pre-school opportunities for all children.

Petition received and read.

Mr Whitlam (Leader of the Opposition) presented a petition from certain residents of New South Wales praying that the export of all kangaroo products be banned immediately.

Petition received and read.

Similar petitions to that presented by Mr Whitlam were presented by Mr Snedden (Minister for Labour and National Service), Mr G. D. Erwin, Mr Jarman, Sir Wilfrid Kent Hughes and Mr Whittorn, from certain residents of Victoria, and were severally received.

- A similar petition to that presented by Mr Whitlam was also presented by Mr Fox, from certain Australian servicemen in Vietnam, and was received.
- 3 QUESTIONS: Questions without notice were asked.
- 4 QUESTIONS ON NOTICE—STATEMENT BY MR SPEAKER: Mr Speaker informed the House that, due to the large number of questions on notice being received and the increasing difficulty being experienced by the Government Printer in the publication of the Notice Paper in the time available, he had fixed half-past five o'clock p.m. as the close-down time, in normal circumstances, for the lodgment of questions for the next day's Notice Paper. The new arrangement would commence on 5 May.
- 5 PAPER: The following paper was presented, pursuant to statute:
 - Sugar Agreement Act—Fruit Industry Sugar Concession Committee—Thirty-eighth Report, and Statement of Receipts and Expenditure certified by the Auditor-General of the Commonwealth, for period 1 September 1968 to 30 June 1969.
- 6 STATES GRANTS (SPECIAL FINANCIAL ASSISTANCE) BILL 1970: Mr Bury (Treasurer), pursuant to notice, presented a Bill for an Act to provide for the payment of certain sums to the States by way of Special Financial Assistance.

Bill read a first time.

Mr Bury moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

- 7 CUSTOMS TARIFF PROPOSALS No. 10 (1970): Mr Chipp (Minister for Customs and Excise) moved Customs Tariff Proposals No. 10 (1970).
 - Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.
- 8 POSTPONEMENT OF ORDERS OF THE DAY: Ordered—That orders of the day Nos. 1 and 2, government business, be postponed until a later hour this day.
- 9 Australian Film Development Corporation Bill 1970: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Message from the Governor-General: Mr Speaker announced the receipt of message No. 10, dated 5 March 1970, from His Excellency the Governor-General recommending an appropriation of revenue for the purposes of the Bill.

The House resolved itself into a committee of the whole.

Mr Hayden moved the following amendment: Clause 6, page 3, line 29, omit "appointed as a member if", insert "precluded from appointment as a member because".

Debate continued.

10 VIETNAM—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Gorton (Prime Minister), by leave, made a ministerial statement informing the House of recent developments in Vietnam and of the decision of the Government to withdraw certain Australian forces from South Vietnam at a time to be determined, and, by command of His Excellency the Governor-General, presented the following paper:

Vietnam—Ministerial statement, 22 April 1970.

Mr Snedden (Leader of the House) moved—That the House take note of the paper. Suspension of standing orders—Extended time for speech: Mr Snedden moved—That so much of the standing orders be suspended as would prevent Mr Whitlam (Leader of the Opposition) speaking without limitation of time.

Question—put and passed, with the concurrence of an absolute majority.

Debate ensued.

Debate adjourned (Mr Jarman), and the resumption of the debate made an order of the day for the next sitting.

11 Australian Film Development Corporation Bill 1970: The House, according to order, again resolved itself into a committee of the whole for the further consideration of the Bill.
