- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
  - 2 PETITIONS: Mr Fox presented a petition from certain residents of New South Wales praying that the export of all kangaroo products be banned immediately. Petition received and read. Similar petitions were presented by Mr L. H. Irwin, and by Mr Solomon and Mr Reid, from certain residents of Victoria, and were severally received.
  - 3 QUESTIONS: Questions without notice were asked.
  - 4 AUSTRALIAN CAPITAL TERRITORY—JOINT COMMITTEE—REPORT—STATEMENT BY MEMBER: Mr Daly (Deputy Chairman) brought up the following report from the Joint Committee on the Australian Capital Territory:  
Report on Australian Capital Territory Milk Industry Inquiry—  
and, by leave, made a statement in connection with the report.  
Ordered—That the report be printed.
  - 5 SPECIAL ADJOURNMENT: Mr Snedden (Leader of the House) moved—That the House, at its rising, adjourn until Tuesday, 2 June, at two o'clock p.m.  
Question—put and passed.
  - 6 PORT AUGUSTA TO WHYALLA RAILWAY BILL 1970: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—  
Debate resumed.  
Question—put and passed—Bill read a second time.  
The House resolved itself into a committee of the whole.

Bill, by leave, taken as a whole, and agreed to, after debate.  
Bill to be reported without amendment.

The House resumed; Mr Lucock reported accordingly.  
On the motion of Mr Sinclair (Minister for Shipping and Transport), the House adopted the report, and, by leave, the Bill was read a third time.

- 7 STATES GRANTS (TEACHERS COLLEGES) BILL 1970: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—  
Debate resumed.

Question—put and passed—Bill read a second time.

*Message from the Governor-General:* Mr Speaker announced the receipt of message No. 25, dated 19 March 1970, from His Excellency the Governor-General recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

Mr N. H. Bowen (Minister for Education and Science) moved—That the Bill be now read a third time.

Debate ensued.

Question—put and passed—Bill read a third time.

- 8 CUSTOMS TARIFF PROPOSALS No. 11 (1970): Mr Hughes (Attorney-General) moved Customs Tariff Proposals No. 11 (1970).

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

- 9 PAPERS: The following papers were presented, by command of His Excellency the Governor-General:

- 10 ADJOURNMENT: Mr Hughes (Attorney-General) moved—That the House do now adjourn.

Debate ensued.

Question—That the question be now put—put and passed.

And the question—That the House do now adjourn—was put accordingly, and passed.

And then the House, at four o'clock p.m., adjourned until Tuesday, 2 June, at two o'clock p.m.
