WEDNESDAY, 10 JUNE 1970

- 1 The House met, at two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr L. R. Johnson presented a petition from certain citizens of the Commonwealth praying that the House take action to reduce the interest rates on Government Bonds and thereby reduce the interest rates on housing loans.
 - Mr Reid presented a petition from certain residents of Victoria praying that the export of all kangaroo products be banned immediately.

Petitions severally received and read.

- Similar petitions to that presented by Mr Reid were presented by Sir Wilfrid Kent Hughes, and by Mr Fox, Mr L. H. Irwin and Mr MacKellar, from certain residents of New South Wales, and were severally received.
- Mr Barnard (Deputy Leader of the Opposition) presented a petition from certain citizens of Flinders Island praying that this House take suitable action to have the Income Tax Assessment Act amended to include Flinders Island in Zone B as defined in Part II of the Second Schedule to that Act.
- Mr Jacobi presented a petition from certain citizens of the Division of Hawker praying that this House take immediate steps to increase the base pension rate to 30 per cent of average weekly male earnings.

Petitions severally received and read.

- A similar petition to that presented by Mr Jacobi was presented by Mr FitzPatrick, from certain citizens of New South Wales, and was received.
- Mr Garrick presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) a joint Commonwealth-State inquiry into inequalities in Australian education, (2) the immediate financing of special programmes for low income earners and others and (3) the provision of preschool opportunities for all children.

Petition received and read.

- A similar petition to that presented by Mr Garrick was presented by Mr Bryant, and was received.

Second to Seventh Schedules (inclusive), at end of each Schedule insert in the first column the number "8289" and in the second column the amounts "1.60", "1.30", "0.95", "0.90", "0.90" and "1.10", respectively.

"(2.) The Director and each Assistant Director shall be paid such other allowances as are prescribed.".

Clause 17-

Mr Garrick moved the following amendment: Page 7, sub-clause (1.), omit from paragraph (f) the words "outside Australia", insert "in Australia or elsewhere".
