WEDNESDAY, 14 OCTOBER 1970

1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.

2 PETITIONS: Mr Bennett presented a petition from certain citizens of Western Australia praying that the House consider the hardship caused to home buyers in that State by the increased interest rates on mortgage contracts which result from the recent increase in the interest rate on Government bonds.

Mr Brown presented a petition from certain citizens of Australia praying that the Government will seek the co-operation of the States and supply extra finance to the States to enable (1) proper town planning and development to halt the increase in densely populated areas which lead to increased crime, (2) the proper staffing and equipping of police forces to enable adequate crime prevention and detection measures to reduce the frightening increase of both solved and unsolved crime, (3) the proper detention of and rehabilitation of criminals and (4) compensation to victims of crimes of violence.

Mr Turner presented a petition from certain citizens of Australia praying that the House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.

Mr Gun presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) the allowance of personal education expenses as a taxation deduction, (2) the removal of the present age limit in respect of the deduction for education expenses, (3) an increase in the deduction allowable for tertiary education expenses, (4) an increase in the maintenance allowance for students and (5) the exemption of non-bonded scholarships for part-time students from income tax.

Mr Wallis presented a petition from certain electors of the Division of Grey praying that this House take immediate steps to increase the base pension rate to 30 per cent of average weekly male earnings.

Petitions severally received and read.

Similar petitions to that presented by Mr Wallis were presented by Mr Jacobi and Mr Gun, from certain citizens of South Australia, and were severally received.

Mr Fox presented a petition from certain residents of New South Wales praying that the export of all kangaroo products be banned immediately.

Petition received.

Mr Wentworth (Minister for Social Services), by leave, presented a petition from certain residents of the United States of America praying that the export of all kangaroo products from Australia be banned immediately.

Petition received and read.

3 QUESTIONS: Questions without notice were asked.

6 PRECEDENCE TO GOVERNMENT BUSINESS: Mr Snedden (Leader of the House) moved, pursuant to notice—That government business shall take precedence over general business tomorrow.

7 ENGINEERING SERVICES, DISTRICT OF DRIPSTONE, DARWIN—APPROVAL OF WORK: Mr Chipp (Minister representing the Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to Parliament: Provision of engineering services, District of Dripstone, Darwin.

Debate ensued.

Question—put and passed.

8 PUBLIC WORKS COMMITTEE—REFERENCE OF WORK—ELECTRICITY SUPPLY POWER STATION, ALICE SPRINGS, N.T.: Mr Chipp (Minister representing the Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1969, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for investigation and report: Construction of an electricity supply power station, Alice Springs, N.T.

Mr Chipp presented plans in connection with the proposed work.

Debate ensued.

Question—put and passed.

9 ASIAN DEVELOPMENT BANK (SPECIAL FUNDS CONTRIBUTIONS) BILL 1970: Mr Bury (Treasurer), pursuant to notice, presented a Bill for an Act to authorize certain Contributions by Australia to the Special Funds of the Asian Development Bank.

Bill read a first time.

Mr Bury moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

10 STATES RECEIPTS DUTIES (ADMINISTRATION) BILL 1970 [No. 2]: Mr Bury (Treasurer) presented a Bill for an Act relating to Duties imposed, at the request of the States, on certain Receipts of Money.

Bill read a first time.

Mr Bury moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

11 STATES RECEIPTS DUTY BILL (No. 1) 1970 [No. 2]: Mr Bury (Treasurer) presented a Bill for an Act to impose, at the request of the States, Duty, being a Duty of Excise, on certain Receipts of Money.

14 STATES RECEIPTS DUTIES (EXEMPTION) BILL 1970: Mr Bury (Treasurer) presented a Bill for an Act to provide for Exemption from Receipts Duties where State Acts relating to duty on Receipts complied with.

Bill read a first time.

Mr Bury moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

15 STATES GRANTS (RECEIPTS DUTY) BILL 1970 [No. 2]: Mr Bury (Treasurer), pursuant to notice, presented a Bill for an Act to provide for the making of Grants to the States of Amounts of Receipts Duty paid to the Commonwealth.

Bill read a first time.

Mr Bury moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.
