## MONDAY, 23 AUGUST 1971

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: Mr Wentworth (Minister for Social Services) and Mr Morrison presented petitions from certain citizens of the Commonwealth praying that this House make legal provision for (1) the allowance of personal education expenses as a taxation deduction, (2) the removal of the present age limit in respect of the deduction for education expenses, (3) an increase in the deduction allowable for tertiary education expenses, (4) an increase in the maintenance allowance for students and (5) the exemption of non-bonded scholarships for part-time students from income tax.
  - Mr Enderby presented a petition from certain electors of Australia praying that the Government revise its interpretation of the Geneva Protocol of 1925 relating to chemical agents of warfare, and declare that it regards all chemical substances employed for their toxic effects on man, animals or plants, as being included in the prohibitions laid down by that Protocol.
  - Mr Morrison and Mr L. H. Irwin presented petitions from certain citizens of Australia praying that this House should cause the Australian Government to recognise the right of Australian professional people engaged in the creative and performing arts to further develop their skills and talents in Australia, and to be protected from overseas programmes in a way that will encourage an Australian television and radio industry.

Petitions severally received.

- Mr Enderby presented a petition from certain residents of the Australian Capital Territory praying that a Committee of Inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration. Petition received and read.
- 3 MINISTERIAL CHANGE—SWEARING-IN AS EXECUTIVE COUNCILLORS OF MEMBERS TO BE APPOINTED AS ASSISTANT MINISTERS: Mr McMahon (Prime Minister) informed the House that Mr J. M. Fraser had been appointed Minister for Education and Science in place of Mr Fairbairn who retained his portfolio of Minister for Defence.
  - Mr McMahon also informed the House that in furtherance of his intention to appoint Assistant Ministers, Mr Dobie, Mr McLeay, Mr Robinson and Mr Street had been sworn as Executive Councillors.
- 4 QUESTIONS: Questions without notice were asked.
- 5 Member Named and suspended: Mr A. D. Fraser having raised a point of order and not having resumed his seat when directed by the Chair to do so, Mr Speaker named the honourable Member for Eden-Monaro (Mr Fraser) for disregarding the authority of the Chair.
  - Mr Swartz (Leader of the House) moved—That the honourable Member for Eden-Monaro be suspended from the service of the House.

9 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—SALE OF WHEAT TO CHINA: Mr Speaker informed the House that Mr Patterson had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The destructive effect of the Australian Government's foreign policy of continued hostility to China on the sale of wheat to that country".

The proposed discussion having received the necessary support— Mr Patterson addressed the House. Discussion ensued.
