# WEDNESDAY, 24 NOVEMBER 1971

- 1 The House met, at two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Wentworth (Minister for Social Services) presented a petition from certain supporters of the Committee to Stop Duffy's Forest Airport praying that this House will at once take appropriate steps to ensure that the Government revokes the lease of the Crown Land belonging to the State of New South Wales and ceases all negotiations for purchase of 37 acres of land privately owned which comprise the 136 acres necessary for the airport site and abandon the proposal to establish an airport at Duffy's Forest.
  - Mr Forbes (Minister for Immigration) presented a petition from certain citizens of Australia praying that the Government will provide \$10 million for relief purposes in India and East Pakistan, and a further \$50 million over 3 years to help rehabilitate the refugees in East Pakistan.
  - Mr Fox, Mr Sherry and Mr Whittorn each presented a petition from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.
  - Mr Kelly presented a petition from certain electors of the Division of Wakefield and Mr Giles presented a petition from certain electors of the Division of Angas praying that section twenty-six of the National Service Act be repealed.
  - Mr Giles also presented a petition from certain electors of South Australia praying that the House will amend the Sales Tax (Exemptions and Classifications) Act and cause such machinery and plant which can be used by vignerons for bulk handling of grapes to be included in that Act as an exemption.
  - Mr Kirwan and Mr Webb each presented a petition from certain electors of Australia praying that the Government revise its interpretation of the Geneva Protocol of 1925 relating to chemical agents of warfare, and declare that it regards all chemical substances employed for their toxic effects on man, animals or plants, as being included in the prohibitions laid down by that Protocol.
  - Mr Bennett presented a petition from certain citizens of Australia praying that the Government will seek the co-operation of the States and supply extra finance to the States to enable (1) proper town planning and development to halt the increase in densely populated areas which lead to increased crime, (2) the proper staffing and equipping of police forces to enable adequate crime prevention and detection measures to reduce the frightening increase of both solved and unsolved crime, (3) the proper detention and rehabilitation of criminals and (4) compensation to victims of crimes of violence.
  - Mr Webb and Mr Kirwan each also presented a petition from certain citizens of Australia praying that this House give earnest consideration to the crisis in Aboriginal welfare which exists in the South West Land Division of Western Australia.
  - Mr Bennett also presented a petition from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.

Petitions severally received.
