3 PETITIONS: Mr Killen and Mr Keogh each presented a petition from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.

Mr Luchetti and Mr L. R. Johnson each presented a petition from certain citizens of Australia praying that this House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.

Mr Staley presented a petition from certain citizens of the community of La Trobe University praying that the Government take immediate action to introduce in order of priority (1) universal Commonwealth Scholarships, (2) Commonwealth Scholarships on the basis of need rather than academic ability and (3) the abolition of tertiary fees.

Mr Turnbull presented a petition from certain residents of Swan Hill, Victoria, praying that the Government will immediately increase aid to \$10 million for Pakistani refugee relief.

Mr Reid and Mr Wallis each presented a petition from certain citizens of Australia praying that the Government will provide \$10 million for relief purposes in India and East Pakistan and a further \$50 million over 3 years to help rehabilitate the refugees in East Pakistan.

Mr Wallis also presented a petition from certain citizens of Australia praying that this House should (1) increase monetary aid for refugees in India to at least \$1 per capita immediately and make provision for a further and extra grant for the victims of the famine in East Pakistan, (2) grant tax deductibility to donations of \$2 and over to Australian voluntary agencies working with the refugee problem and (3) ensure that the Australian Government does all in its power to help bring about a political settlement which would be acceptable to the people of East Pakistan.

Mr Lloyd presented a petition from certain citizens of Australia praying that the Government will (1) immediately increase aid, monetary or otherwise, for Pakistani refugee relief to the value of \$10 million, (2) grant as aid, on a continuing basis, a percentage of the gross national product, and (3) use every diplomatic channel possible to ease tension between the Indian and Pakistani Governments.

Mr L. R. Johnson also presented a petition from certain citizens of Australia praying that this House will (1) take immediate steps to make emergency finance available to the States for State school education and (2) divert the large sums of public money being spent on private schools to the government school system for which the Government is truly responsible.

Mr Howson (Minister for the Environment, Aborigines and the Arts) presented a petition from certain citizens of the Commonwealth praying that this House should urge that the Government cease all aid to the West Pakistan Government, either directly or through SEATO where this may be used for military purposes, and that such aid be applied for the relief of the refugees.

Mr Enderby presented a petition from certain citizens of the Australian Capital Territory praying that the words "or for preventing conception" be deleted from sub-section (1.) of section 46 of the A.C.T. Pharmacy Ordinance.

Mr Enderby also presented a petition from certain residents of the Australian Capital Territory praying that a committee of inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration.

Clause 34, page 12, at the end of the clause add the following sub-clause:

“(6.) The references in this section to the Register shall be read as references to the special section of the Register established in accordance with section 42 of this Act, and nothing in this section applies in relation to information contained in the portion of the Register other than the special section of the Register.”.

Clause 42, page 18, at the end of the clause add the following sub-clauses:

“(3.) The regulation shall provide for the maintenance of a special section of the Register, and for the filing in that section of such particulars as the Commissioner may direct, being—

(a) particulars containing information the publication of which would, in the opinion of the Commissioner, be contrary to the public interest; or

(b) particulars containing information as to any secret process of manufacture or as to the presence, absence or situation of any mineral or other deposits or as to any other similar matter, being information the publication of which, in the opinion of the Commissioner, would substantially damage the legitimate business interests of any person.

(4.) The Register, other than the special section, shall be open to public inspection during such hours and subject to payment of such fee as may be prescribed by the regulations.

(5.) Any person may, upon payment of such fee as may be prescribed by the regulations, require the Commissioner to supply to him a copy of, or extract from, any particulars filed in the Register, other than the special section, certified by the Commissioner to be a true copy or extract.”.
