- 1 The House met, at two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Mackay (Minister for the Navy), Mr Hayden, Mr Graham, Mr Reynolds, Sir John Cramer, Mr Luchetti, Mr MacKellar, Mr Bury and Mr L. R. Johnson each presented a petition from certain citizens of the Commonwealth praying that the Government immediately provide \$10 million in direct aid to refugees now in India and commit itself to a continuing aid programme.
 - Mr Jones, Mr Hansen, Mr Webb and Mr McIvor each presented a petition from certain citizens of the Commonwealth praying that the Government (1) immediately increase Australia's contribution to the refugee appeal by \$10 million and (2) press for a just solution to the conflict, so that the refugees may return to their homes.
 - Mr A. D. Fraser presented a petition from certain citizens of the community of the Australian National University and Mr Bryant presented a petition from certain citizens of the community of Flinders University praying that the Government take immediate action to introduce in order of priority (1) universal Commonwealth scholarships, (2) Commonwealth scholarships on the basis of need rather than academic ability and (3) the abolition of tertiary fees.
 - Mr Cross and Mr Bryant each presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) the allowance of personal education expenses as a taxation deduction, (2) the removal of the present age limit in respect of the deduction for education expenses, (3) an increase in the deduction allowable for tertiary education expenses and (4) the exemption of non-bonded scholarships for part-time students from income tax.
 - Mr Enderby presented a petition from certain residents of the Australian Capital Territory praying that a committee of inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration.
 - Mr Reid presented a petition from certain citizens of Australia praying that the Government will provide \$10 million for relief purposes in India and East Pakistan, and a further \$50 million over 3 years to help rehabilitate the refugees in East Pakistan.
 - Mr Lloyd presented a petition from certain citizens of Australia praying that the Government will (1) immediately increase aid, monetary or otherwise, for Pakistani refugee relief to the value of \$10 million, (2) grant as aid, on a continuing basis, a percentage of the gross national product, and (3) use every diplomatic channel possible to ease tension between the Indian and Pakistani Governments.

- Mr L. K. Johnson presented a petition from certain citizens of the Commonwealth praying that the Government will (1) press for a just solution, primarily through the United Nations, to the refugee crisis in India so that the refugees may return to their own homes, (2) forward high initial aid to alleviate present starvation and sickness and (3) continue economic aid through development programmes involving Australian capital and personnel.
- Mr Calwell presented a petition from certain citizens of Australia praying that this House should (1) grant income tax deductions for donations over \$2 made towards the relief of overseas disaster areas and (2) effect this with haste to ensure the maximum possible aid to those at present in refugee camps and those in danger of famine in East Pakistan.
- Mr A. D. Fraser, Mr MacKellar and Mr Calwell each also presented a petition from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.
- Mr Cross also presented a petition from certain citizens of Australia praying that this House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.
- Mr Bryant also presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) Aboriginal ownership of existing reserves throughout the Commonwealth, (2) the recognition of Aboriginal ownership of traditional land at present owned and leased by the Crown and (3) the development of mining, pastoral and other enterprises on all Aboriginal land to be subject to the consent of Aboriginal owners and such conditions as their own legal advisers may arrange.
- Mr Klugman and Mr A. D. Fraser each presented a petition from certain citizens of Australia praying that this House will (1) take immediate steps to make emergency finance available to the States for State school education and (2) divert the large sums of public money being spent on private schools to the government school system for which the Government is truly responsible.
- Mr Cross also presented a petition from certain electors of Australia praying that the Government revise its interpretation of the Geneva Protocol of 1925 relating to chemical agents of warfare, and declare that it regards all chemical substances employed for their toxic effects on man, animals or plants, as being included in the prohibitions laid down by that Protocol.

Petitions severally received.

Mr MacKellar also presented a petition from certain supporters of the Committee to Stop Duffy's Forest Airport praying that this House will at once take appropriate steps to ensure that the Government revokes the lease of the Crown Land belonging to the State of New South Wales and ceases all negotiations for purchase of 37 acres of land privately owned which comprise the 136 acres necessary for the airport site and abandon the proposal to establish an airport at Duffy's Forest.

Petition received and read.

6 STOKES HILL POWER STATION, DARWIN—STAGE 5 EXTENSIONS—APPROVAL OF WORK: Mr Chipp (Minister representing the Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to Parliament: Construction of stage 5 extensions, Stokes Hill Power Station, Darwin.

Debate ensued.

Question-put and passed.

7 BRUCELLA VACCINE TESTING LABORATORY, CANBERRA—APPROVAL OF WORK: Mr Chipp (Minister representing the Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to Parliament: Construction of a brucella vaccine testing laboratory at Canberra.

Debate ensued.

Question-put and passed.

8 Customs Bill (No. 2) 1971: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Hayden who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "this House is of opinion that the Bill should be withdrawn and redrafted to deal comprehensively with (a) drug trafficking, drug pushing and the provision of penalties severe enough to deter these offences and (b) drug abuse and the treatment and rehabilitation of addicts based on the humanitarian approach recommended by the Senate Select Committee on Drug Trafficking and Drug Abuse".

Debate continued.

Mr L. F. Bowen was granted leave to continue his speech when the debate is resumed. Debate adjourned, and the resumption of the debate made an order of the day for a later hour this day.

 - (1) a Parliamentary Allowances Bill, a Ministers of State Bill (No. 2) and a Parliamentary Allowances Tribunal Bill—
 - (a) being presented and read a first time together and one motion being moved without delay and one question being put in regard to, respectively, the second readings, the committee's report stage, and the third readings, of all the Bills together, and
 - (b) the consideration of the Bills in one committee of the whole and
 - (2) a Salaries Adjustment Bill being presented and passed through all its stages without delay.

Question—put and passed.

"(ca) where the narcotic goods in relation to which the offence was committed consist of a quantity of a narcotic substance (being the narcotic substance specified in the information, complaint, declaration, claim or indictment as the narcotic substance of which the goods consist) and where the court is satisfied that the offence was committed by the person charged for any purpose related to the sale of, or other commercial dealing in, the narcotic goods in relation to which the offence was committed—a fine not exceeding Four thousand dollars or imprisonment for a period not exceeding ten years, or both a fine not exceeding that amount and imprisonment for a period not exceeding that period; or".
