HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

No. 156

THURSDAY, 9 MARCH 1972

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Cope presented a petition from certain citizens of Australia praying that the Government will immediately enact legislation providing for a base pension rate of 30 per cent of average weekly male earnings and other health and social service changes and initiate a public inquiry into Australia's social welfare structure. Petition received.
 - Mr Enderby presented a petition from certain residents of the Australian Capital Territory praying that the Government will not enact any law that would detract from or hinder the rights of the Aborigines to be on the lawns outside Parliament House, and that the Government instruct its officers not to interfere with the Aborigines peacefully assembled there.

Petition received and read.

- Mr Enderby informed the House that he proposed to take action in connection with the petition, and moved—That the petition be printed.

 Question—put and passed.
- 3 QUESTIONS: Questions without notice were asked.
- 4 CRAFTS—COMMITTEE OF INQUIRY—MINISTERIAL STATEMENT: Mr Howson (Minister for the Environment, Aborigines and the Arts), by leave, made a ministerial statement relating to the establishment of a committee to undertake an inquiry into the state of crafts in Australia.
 - Mr Hayden, by leave, also made a statement with reference to the matter.
- 5 Special adjournment: Mr Swartz (Leader of the House) moved—That the House, at its rising, adjourn until Tuesday, 21 March, at half-past two o'clock p.m. Ouestion—put and passed.
- 6 Public Accounts Committee—Report—Statement by Member: Mr Graham (Chairman) brought up the following report from the Joint Committee of Public Accounts:

10 AGED PERSONS HOMES—PAPER AND MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPERS: Mr Wentworth (Minister for Social Services), by command of His Excellency the Governor-General, presented the following paper:

12 Public Service Arbitration Bill 1972: Mr Lynch (Minister for Labour and National Service), pursuant to notice, presented a Bill for an Act relating to the Settlement of Matters arising out of Employment in the Public Service.

Bill read a first time.

Mr Lynch moved—That the Bill be now read a second time.

Debate adjourned (Mr C. R. Cameron), and the resumption of the debate made an order of the day for the next sitting.

13 STATES GRANTS (INDEPENDENT SCHOOLS) BILL 1972: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Beazley, viz.—That all words after "That" be omitted with a view to inserting the following words in place thereof: "the House, while not refusing a second reading to the Bill, is of the opinion that it should provide for the establishment of an Australian Schools Commission to examine and determine the needs of students in government and non-government primary, secondary and technical schools, and recommend grants which the Commonwealth should make to the States to assist in meeting the requirements of all school age children on the basis of needs and priorities"—

Debate resumed.
