WEDNESDAY, 22 MARCH 1972

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: Mr Fairbairn (Minister for Defence), Mr Beazley, Mr Daly, Mr Dobie, Mr Street, Mr Hurford, Mr Drury, Mr Enderby, Mr Lloyd, Mr Connor, Mr Bonnett, Mr Foster, Mr Buchanan, Mr Armitage, Mr Lucock, Mr Fulton, Mr Griffiths, Mr Solomon, Mr A. D. Fraser, Mr L. F. Bowen, Mr Scholes, Mr Wallis, Mr Nicholls, Mr James, Mr Hansen, Mr Duthie and Mr Graham each presented a petition from certain citizens of Australia praying that the House will take immediate steps to call a halt to the closing of post offices and the reorganisation of the Post Office and initiate a joint parliamentary inquiry into the Postmaster-General's Department.
 - Mr Daly, Mr Foster, Mr Birrell, Mr Griffiths, Mr Garrick, Mr Scholes and Mr Reynolds each presented a petition from certain citizens of Australia praying that the Government will immediately enact legislation providing for a base pension rate of 30 per cent of average weekly male earnings and other health and social service changes and initiate a public inquiry into Australia's social welfare structure.

Petitions severally received.

Mr Foster also presented a petition from certain citizens of the Commonwealth praying that the House will appoint a nominee of the Craft Council of Australia to the Federal Government committee investigating the role of crafts as an art form.

Petition received and read.

- Similar petitions to that presented by Mr Foster on crafts were presented by Mr Jacobi and Mr Hurford, and were severally received.
- Mr Solomon and Mr Sherry each presented a petition from certain citizens of Australia praying that this House will (1) take immediate steps to make emergency finance available to the States for State school education and (2) divert the large sums of public money being spent on private schools to the government school system for which the Government is truly responsible.
- Mr Jarman presented a petition from certain residents of Victoria praying that the House will (1) immediately take action to see that State governments prohibit the commercial shooting of kangaroos and (2) enact legislation to give the Commonwealth Government responsibility throughout Australia for all native wildlife and habitat upon which it is dependent for survival.
- Mr Berinson presented a petition from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.

- Mr Solomon also presented a petition from certain citizens of the community of the University of Tasmania praying that the Government take immediate action to introduce in order of priority (1) universal Commonwealth scholarships, (2) Commonwealth scholarships on the basis of need rather than academic ability and (3) the abolition of tertiary fees.
- Mr Enderby also presented a petition from certain residents of the Australian Capital Territory praying that a committee of inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration. Petitions severally received.
- 3 MINISTERIAL CHANGE AND ARRANGEMENTS: Mr McMahon (Prime Minister) informed the House that Mr Garland (Minister for Supply) had been appointed Minister assisting the Treasurer.
 - Mr McMahon also informed the House that, during the forthcoming absence abroad of Mr Nixon (Minister for Shipping and Transport), Mr Hunt (Minister for the Interior) would act as Minister for Shipping and Transport.
- 4 QUESTIONS: Questions without notice were asked.
- 5 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—FOREIGN CONTROL OF AUSTRALIAN INDUSTRIES AND RESOURCES: Mr Speaker informed the House that Mr Crean had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The increasing control of Australian industries and resources by foreign companies".

The proposed discussion having received the necessary support— Mr Crean addressed the House. Discussion ensued.

Discussion concluded.

6 PAPUA NEW GUINEA LOAN (ASIAN DEVELOPMENT BANK) BILL 1972: Mr Garland (Minister assisting the Treasurer), for Mr Snedden (Treasurer), pursuant to notice, presented a Bill for an Act relating to a Loan to the Administration of Papua New Guinea by the Asian Development Bank.

Bill read a first time.

Mr Garland moved-That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

10 COMMONWEALTH TEACHING SERVICE BILL 1972: The order of the day having been read for the resumption of the debate on the question-That the Bill be now read a second time-

Debate resumed by Mr Beazley who moved, as an amendment-That all words after "That" be omitted with a view to inserting the following words in place thereof: "the House, while not refusing a second reading to the Bill, is of the opinion that it should provide (a) for the provision of a Commission of three members for the Commonwealth Teaching Service, one of whom shall be elected by teachers, (b) for the heightening of professional standards of teachers in the Commonwealth Teaching Service by empowering the Commission to negotiate for the establishment of Faculties of Education in universities where necessary, including the Australian National University, (c) for the active encouragement of recruitment and training of teaching staff, not only for Papua New Guinea should it desire this assistance, but for other islands of the Pacific the Governments of which seek such aid, (d) for the provision of an advisory council to assist the Commission, this council to be representative of the community and of educational research and administrative bodies, and (e) for leave for pregnancy in conformity with the International Labour Organization recommendation and also to provide generous leave in event of difficult pregnancies or in event of a disability of the infant which requires the mother's attention for a period after the birth".
