## WEDNESDAY, 17 MAY 1972

- 1 The House met, at two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: The Acting Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
  - Mr Katter (Minister for the Army), Mr Calwell, Mr Bate, Mr Brown, Mr Daly, Mr Everingham, Mr Hansen, Mr Hayden, Mr L. K. Johnson, Mr Keogh, Mr Killen, Mr Scholes, Mr Stewart, Mr Uren and Mr Webb—from certain citizens of Australia praying that the Government will immediately enact legislation providing for a base pension rate of 30 per cent of average weekly male earnings and other health and social service changes and initiate a public inquiry into Australia's social welfare structure.
  - Mr Drury and Mr A. D. Fraser—from certain citizens of Australia praying that the House will take immediate steps to call a halt to the closing of post offices and the reorganisation of the Post Office and initiate a joint parliamentary inquiry into the Postmaster-General's Department.
  - Mr Bryant—from certain citizens of the Commonwealth praying that this House will take whatever action is necessary to ensure that the new and permanent Parliament House is built on the Capital Hill site and not Camp Hill as previously announced.
  - Mr Grassby—from certain Aborigines and non-Aboriginal citizens of Australia praying that this House will make legal provision for (1) adequate, high standard housing for the Aboriginal people on sites acceptable to the Aboriginal persons concerned (2) employment opportunities in the district for all those able to work and (3) full legal title to the land on all reserves for those residents of the reserve.
  - Mr Keating—from certain employees of the Australian Aircraft Industry and citizens of the Commonwealth praying that the Government will assist the Australian Aircraft Industry with respect to aircraft purchases, spares, military equipment exports, and participation in aero-space projects.

4 INTERNATIONAL MONETARY SITUATION—MINISTERIAL STATEMENT, 17 MAY 1972—MOTION TO TAKE NOTE OF PAPER: Mr Snedden (Treasurer), by leave, made a ministerial statement with reference to the international monetary situation, and, by command of His Excellency the Governor-General, presented the following paper:

Constitution of Council. "12.-(1.) The Council shall consist of a Chairman and at least seven other members.

(2.) The Chairman shall be appointed by the Governor-General from a panel submitted by the Australian Academy of Science.

(3.) Two members shall be appointed by the Governor-General from a panel submitted by the Australian Marine Science Association.

(4.) Two members shall be appointed by the Governor-General from a panel submitted by the Great Barrier Reef Committee.

(5.) One member shall be appointed by the Governor-General from a panel submitted by the Geological Society of Australia.

(6.) One member shall be a Senator elected by the Senate.

(7.) One member shall be a Member of the House of Representatives elected by that House.

(8.) Such other members, as are deemed necessary from time to time, may be appointed by the Governor-General, but so that of every three members of the Council two shall be persons possessing scientific qualifications.

(9.) A member of the Council elected by either House of the Parliament holds office, subject to this Act, for such period, not exceeding five years as is fixed by that House at the time of his election.

(10.) Subject to this Act each member appointed by the Governor-General holds office for such period, not exceeding five years, as is specified in the instrument of his appointment and on such terms and conditions as the Governor-General determines, but is eligible for re-appointment.

(11.) An act or decision of the Council is not invalid by reason only of a vacancy or vacancies in the membership of the Council.".
