TUESDAY, 15 AUGUST 1972

- 1 The House met, at three o'clock p.m., according to the terms of the resolution of 31 May last. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 DEATH OF DUKE OF WINDSOR—REPLY TO ADDRESS OF CONDOLENCE: Mr Speaker informed the House that the following reply to the Address of Condolence agreed to by the House on the death of His Royal Highness the Duke of Windsor had been received by the Governor-General from the Private Secretary to Her Majesty The Queen:

"I am commanded to acknowledge the receipt of the address from both the Senate and the House of Representatives sent on the occasion of the death of The Duke of Windsor and to say that Her Majesty deeply appreciates the expressions of sympathy sent on behalf of the people of the Commonwealth of Australia.".

- 3 DEATH OF THE RIGHT HONOURABLE SIR OWEN DIXON: Mr McMahon (Prime Minister) referred to the death, on 7 July 1972, of the Right Honourable Sir Owen Dixon, O.M., G.C.M.G., a former Chief Justice of the High Court of Australia, paid tribute to his memory and extended sympathy to his family.
 - Mr Whitlam (Leader of the Opposition) and Mr Anthony (Leader of the Australian Country Party) supported the remarks of the Prime Minister.

As a mark of respect to the memory of the deceased all Members stood, in silence.

- 4 DEATH OF FORMER MEMBER (THE HONOURABLE ARTHUR BLAKELEY): Mr McMahon (Prime Minister) referred to the death, on 27 June 1972, of the Honourable Arthur Blakeley, a Member of this House for the Division of Darling from 1917 to 1934, and a Minister of the Crown from 1929 to 1932 and extended sympathy to his family.
 - Mr Whitlam (Leader of the Opposition) and Mr Anthony (Leader of the Australian Country Party) supported the remarks of the Prime Minister.
 - As a mark of respect to the memory of the deceased all Members stood, in silence.
- 5 Petitions: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
 - Mr Chipp (Minister for Customs and Excise), Sir John Cramer, Mr Grassby, Mr Gun, Mr Keogh, Mr McIvor, Mr Morrison, Mr Reid and Mr Wallis—from certain citizens of the Commonwealth praying that Australia's official development assistance in 1972–73 be increased to at least \$240 million, and that Australia's aid and trade policies be reviewed to benefit developing countries.
 - Mr Chipp—from certain electors of the Division of Hotham praying that the Government immediately take all necessary action, and, where necessary, act in co-operation with the States to prohibit the importation, production, display or sale of any indecent material.
 - Mr Hunt (Minister for the Interior)—from certain Aboriginal and non-Aboriginal, islander and non-islander electors of Australia praying that the proposed legislation to enable the Government to abolish the Aboriginal "Embassy" be immediately withdrawn, that the Government grant Aborigines the land rights they demand and that the Aboriginal "Embassy" be given free and dignified accommodation befitting ambassadorial status in Canberra City.

- Mr Hunt—from certain citizens of New South Wales praying that this House will give urgent consideration to improving the educational opportunities of children living in isolated areas through the granting of certain financial aid, accommodation and travelling allowances.
- Mr Garland (Minister for Supply)—from certain citizens of the Commonwealth praying that the Income Tax Assessment Act be amended to allow as deductions the cost of special foods required by diabetics.
- Mr Katter (Minister for the Army)—from certain citizens of Australia praying that the House will take immediate steps to have the Commonwealth Public Service Board alter its policy on the review of district allowances payable to officers stationed in remote localities and carry out reviews every two years.
- Mr Gorton—from certain citizens of the Commonwealth praying that the Government will legislate to aid single supporting mothers either by making the cost of providing or using nursery facilities tax deductible or through the provision of free child minding centres.
- Mr Calwell, Mr L. R. Johnson and Mr McIvor—from certain citizens of Australia praying that the Government will immediately enact legislation providing for a base pension rate of 30 per cent of average weekly male earnings and other health and social service changes and initiate a public inquiry into Australia's social welfare structure.
- Mr Bennett—from certain residents of Western Australia praying that this House take immediate steps to ensure provision of funds to provide for the all-weather sealing of the Eyre Highway.
- Mr Bennett—from certain residents of Western Australia praying that action be taken to move the Perth Airport from its present site.
- Mr Giles—from certain citizens of the Commonwealth praying that every possible step be taken to persuade the French Government to stop the testing of nuclear devices in the Pacific area.
- Mr Grassby—from certain electors of New South Wales praying that this House will immediately make a substantial federal emergency grant to all State Governments for education services and carry out a public national survey to determine needs of the States after 1975.
- Mr L. R. Johnson and Mr Keogh—from certain citizens of Australia praying that the House will take immediate steps to call a halt to the closing of post offices and the reorganisation of the Post Office and initiate a joint parliamentary inquiry into the Postmaster-General's Department.
- Mr Morrison—from certain citizens of Australia praying that this House will (1) take immediate steps to make emergency finance available to the States for State school education and (2) divert the large sums of public money being spent on private schools to the government school system for which the Government is truly responsible.
- Mr Reynolds—from certain citizens of Australia praying that the curfew at Sydney (Kingsford-Smith) Airport be rigidly enforced, noise limits be placed on aircraft operating there, the operating rights of companies persistently violating the limits be withdrawn and the site of a second airport for Sydney be selected without further delay.
