THE PARLIAMENT OF THE COMMONWEALTH OF AUSTRALIA

HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

No. 196

TUESDAY, 26 SEPTEMBER 1972

- 1 The House met, at eleven o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
 - Mr Lynch (Minister for Labour and National Service), Mr Whitlam (Leader of the Opposition), Mr Armitage, Mr L. F. Bowen, Mr Everingham, Mr Garrick and Mr Gun—from certain citizens of the Commonwealth praying that the contract let to an American controlled company for the advertising rights for the Victorian Pink Pages Telephone Directories be revoked in the national interest.
 - Mr Chipp (Minister for Customs and Excise), Mr Grassby, Mr Gun, Mr MacKellar, Mr Patterson and Mr Reid—from certain citizens of the Commonwealth praying that Australia's official development assistance in 1972–73 be increased to at least \$240 million, and that Australia's aid and trade policies be reviewed to benefit developing countries.
 - Mr Armitage and Mr Luchetti—from certain residents of the western suburbs in the Sydney metropolitan area and surrounding districts praying that this House take appropriate steps to ensure that the Government does not proceed with the proposal to site the second twenty-four hour international airport for Sydney at Richmond or anywhere else in the far western suburbs of the metropolitan area.
 - Mr Enderby—from certain employees in Parliament House, Canberra, praying that an early decision will be taken by the Government to build the new and permanent Parliament House which will, in the long run, be a more economical way to house the Parliament and which will at the same time be an impressive and proud symbol of Australia's progress and national unity.
 - Mr Enderby—from certain residents of the Australian Capital Territory praying that the strip of land on the whole western side of Melrose Drive, Canberra, be reserved for development as parkland.
 - Mr L. K. Johnson—from certain citizens of Australia praying that the Government will immediately enact legislation providing for a base pension rate of 30 per cent of average weekly male earnings and other health and social service changes and initiate a public inquiry into Australia's social welfare structure.
 - Mr Luchetti—from certain citizens of the Commonwealth praying that the Government reconsider its attitude towards accepting into Australia some of the displaced Ugandan Asians, send a mission to Uganda to assess the Ugandan Asians' attitude to coming to Australia and assist with the settlement of these people, wherever that may be.
 - Mr Whitlam—from certain citizens of Australia praying that this House will (1) take immediate steps to make emergency finance available to the States for State school education and (2) divert the large sums of public money being spent on private schools to the government school system for which the Government is truly responsible.
 - Mr Whitlam—from certain citizens of the community of Canberra praying that this House will call on the Government to repeal the *Trespass on Commonwealth Lands Ordinance* 1972.

- 12 STATES GRANTS (ABORIGINAL ADVANCEMENT) BILL 1972: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr J. F. Cairns who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "while not opposing the provisions of the Bill, the House condemns the Government for (a) its failure over a period of more than five years to exercise the full and direct responsibility in Aboriginal Affairs voted to it by more than 90 per cent of the Australian electorate in the referendum of May 1967, (b) neglecting to consult with the Aboriginal people, (c) refusing to restore land rights to Aborigines living on reserves or in significant communities, (d) failing to provide decent housing for Aboriginal families, (e) failing to provide employment opportunities particularly in rural areas, (f) making insufficient provision for education ranging from pre-school to technical training, adult education and education at university level, (g) its indifference to indefensible levels of neo-natal, infant and child mortality, malnutrition and disease, (h) its failure to assist the States in meeting these responsibilities beyond their own financial capacity and (i) its failure to provide the leadership which is a clear Commonwealth responsibility".

should make to the States to assist in meeting the requirements of all school age children on the basis of needs and priorities and that the application of this policy could not allow the continued acceptance of the provisions of the Bill and that therefore grants should not be made on the basis provided in the Bill in respect of any year after 1973".
