# HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

No. 201

# THURSDAY, 12 OCTOBER 1972

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
  - Mr Lynch (Minister for Labour and National Service), Mr Bury, Mr Gun, Mr Kennedy and Mr Turner—from certain citizens of the Commonwealth praying that Australia's official development assistance in 1972–73 be increased to at least \$240 million, and that Australia's aid and trade policies be reviewed to benefit developing countries.
  - Mr Peacock (Minister for External Territories), Mr K. M. K. Cairns (Minister for Housing), Mr Brown, Mr Bury and Mr Duthie—from certain citizens of the Commonwealth praying that the contract let to an American controlled company for the advertising rights for the Victorian Pink Pages Telephone Directories be revoked in the national interest.
  - Mr C. R. Cameron and Mr Enderby—from certain citizens of Australia praying that this House will take immediate steps to have the Commonwealth Public Service Board take certain action regarding an increase in wage rates and the promotion structure of the Manipulative Group in the Public Service.
  - Mr Duthie—from certain citizens of Australia praying that this House will, in regard to the use of Commonwealth funds to aid church schools, restore to the Australian people true religious freedom which can exist only when Church and State are legally separated both in form and substance.
  - Mr Enderby—from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.
  - Mr Enderby—from certain residents of the Australian Capital Territory praying that the strip of land on the whole western side of Melrose Drive, Canberra, be reserved for development as parkland.
  - Mr Foster—from certain residents of South Australia praying that this House urge the Government to take certain action to ensure the survival of kangaroos and implement the recommendations made by the House of Representatives Select Committee on Wildlife Conservation in its interim report on kangaroos.
  - Mr Grassby—from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.
  - Mr Gun—from certain citizens of Australia praying that this House will move to make available to the Tasmanian Government a special grant for the express purpose of preserving Lake Pedder in its natural state.

Petitions received.

3 QUESTIONS: Questions without notice being asked—

  - (d) where any document referred to in paragraph (c) was withheld for security reasons, a statement indicating the subject and classification of that document. Debate ensued.

Clause 40, page 20, at the end of the clause add the following paragraph:

"(h) make arrangements for the operation of an approved marketing scheme to acquire and/or market the Australian wool clip.".

Debate resumed by Mr Patterson who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "whilst not declining to give the Bill a second reading, the House is of opinion that The Schedule should make provision for (a) applications to be accepted up to 30 June 1974, and (b) assistance to be paid for trees removed up to 31 October 1974".
