## TUESDAY, 27 MARCH 1973

- 1 The House met, at two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 Petition: The Clerk announced that Mr Lynch (Deputy Leader of the Opposition) had lodged a petition for presentation from certain electors of the Division of Flinders praying that the House will take immediate steps to restore and improve the former rehabilitation centre "Maryport" to allow it to re-open as quickly as possible. Petition received.
- 3 MINISTERIAL ARRANGEMENTS: Mr Whitlam (Prime Minister) informed the House that, during the absence abroad of Mr Crean (Treasurer), Mr Hayden (Minister for Social Security) was acting as Treasurer.
- 4 QUESTIONS: Questions without notice being asked—

Distinguished visitors: Mr Speaker informed the House that a delegation from the People's Assembly of the Arab Republic of Egypt, led by the Honourable Fuad Abu Hemeila, was present in the gallery. On behalf of the House, Mr Speaker extended to the visitors a warm welcome.

- 7 Australian Capital Territory—Proposed Joint Committee: Mr Enderby (Minister for the Capital Territory) moved, pursuant to notice—
  - (1) That a Joint Committee be appointed to-
    - (a) examine and report or, all proposals for modifications or variations of the plan of lay-out of the City of Canberra and its environs published in the Commonwealth of Australia Gazette on the nineteenth day of November 1925, as previously modified or varied, which are referred to the committee by the Minister for the Capital Territory; and
    - (b) examine and report on such other matters relating to the Australian Capital Territory as may be referred to the committee—
      - (i) by the Minister for the Capital Territory; or
      - (ii) by resolution of either House of the Parliament.
  - (2) That the committee consist of three Members of the House of Representatives nominated by the Prime Minister, one Member of the House of Representatives nominated by the Leader of the Opposition in the House of Representatives, one Member of the House of Representatives nominated by the Leader of the Australian Country Party in the House of Representatives, two Senators nominated by the Leader of the Government in the Senate, and two Senators nominated by the Leader of the Opposition in the Senate.
  - (3) That every nomination of a member of the committee be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
  - (4) That the members of the committee hold office as a joint committee until the House of Representatives expires by dissolution or effluxion of time.
  - (5) That the Prime Minister nominate one of the government members of the committee as Chairman.
  - (6) That the Chairman of the committee may, from time to time, appoint another member of the committee to be the Deputy Chairman of the committee, and that the member so appointed act as Chairman of the committee at any time when the Chairman is not present at a meeting of the committee.
  - (7) That the committee have power to appoint sub-committees consisting of three or more of its members and to refer to any such sub-committee any of the matters which the committee is empowered to examine.
  - (8) That the committee have power to send for persons, papers and records, to move from place to place and to sit during any recess or adjournment of the Parliament.
  - (9) That the committee have leave to report from time to time and that any member of the committee have power to add a protest or dissent to any report.
  - (10) That five members of the committee constitute a quorum of the committee, and two members of a sub-committee constitute a quorum of that sub-committee.
  - (11) That in matters of procedure the Chairman or Deputy Chairman presiding at the meeting have a deliberative vote and in the event of an equality of voting, have a casting vote, and that, in other matters, the Chairman or Deputy Chairman have a deliberative vote only.
  - (12) That the committee have power to consider and make use of the minutes of evidence and records of the Joint Committees on the Australian Capital Territory, appointed in previous Parliaments, relating to any matters which are again referred to the committee.
  - (13) That the committee may proceed to the despatch of business notwithstanding that all members of the committee have not been appointed and notwithstanding any vacancy on the committee.

- (14) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
- (15) That a message be sent to the Senate acquainting it of this resolution and requesting that it concur and take action accordingly.

Debate adjourned (Mr Fraser), and the resumption of the debate made an order of the day for the next sitting.

- 8 NORTHERN TERRITORY—PROPOSED JOINT COMMITTEE: Mr Enderby (Minister for the Northern Territory) moved, pursuant to notice—
  - (1) That a Joint Committee be appointed to inquire into and report on such matters relating to the Northern Territory as are referred to it—

(a) by the Minister for the Northern Territory; or

(b) by resolution of either House of the Parliament.

- (2) That the committee consist of three Members of the House of Representatives nominated by the Prime Minister, one Member of the House of Representatives nominated by the Leader of the Opposition in the House of Representatives, one Member of the House of Representatives nominated by the Leader of the Australian Country Party in the House of Representatives, two Senators nominated by the Leader of the Government in the Senate and two Senators nominated by the Leader of the Opposition in the Senate.
- (3) That every nomination of a member of the committee be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
- (4) That the members of the committee hold office as a joint committee until the House of Representatives expires by dissolution or effluxion of time.
- (5) That the Prime Minister nominate one of the government members of the committee as Chairman.
- (6) That the Chairman of the committee may, from time to time, appoint another member of the committee to be the Deputy Chairman of the committee, and that the member so appointed act as Chairman of the committee at any time when the Chairman is not present at a meeting of the committee.
- (7) That the committee have power to appoint sub-committees consisting of three or more of its members and to refer to any such sub-committee any of the matters which the committee is empowered to examine.
- (8) That the committee have power to send for persons, papers and records, to move from place to place and to sit during any recess or adjournment of the Parliament.
- (9) That the committee have leave to report from time to time and that any member of the committee have power to add a protest or dissent to any report.
- (10) That the committee may proceed to the despatch of business notwithstanding that all members of the committee have not been appointed and notwithstanding any vacancy on the committee.
- (11) That five members of the committee constitute a quorum of the committee, and two members of a sub-committee constitute a quorum of that sub-committee.
- (12) That in matters of procedure the Chairman or Deputy Chairman presiding at the meeting have a deliberative vote and, in the event of an equality of voting, have a casting vote, and that, in other matters, the Chairman or Deputy Chairman have a deliberative vote only.
- (13) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
- (14) That a message be sent to the Senate acquainting it of this resolution and requesting that it concur and take action accordingly.

Debate adjourned (Mr Fraser), and the resumption of the debate made an order of the day for the next sitting.
