- 14 NORTHERN TERRITORY—PROPOSED JOINT COMMITTEE: The order of the day having been read for the resumption of the debate on the motion of Mr Enderby (Minister for the Northern Territory)—
  - (1) That a Joint Committee be appointed to inquire into and report on such matters relating to the Northern Territory as are referred to it—
    - (a) by the Minister for the Northern Territory; or
    - (b) by resolution of either House of the Parliament.
  - (2) That the committee consist of three Members of the House of Representatives nominated by the Prime Minister, one Member of the House of Representatives nominated by the Leader of the Opposition in the House of Representatives, one Member of the House of Representatives nominated by the Leader of the Australian Country Party in the House of Representatives, two Senators nominated by the Leader of the Government in the Senate and two Senators nominated by the Leader of the Opposition in the Senate.
  - (3) That every nomination of a member of the committee be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
  - (4) That the members of the committee hold office as a joint committee until the House of Representatives expires by dissolution or effluxion of time.
  - (5) That the Prime Minister nominate one of the government members of the committee as Chairman.
  - (6) That the Chairman of the committee may, from time to time, appoint another member of the committee to be the Deputy Chairman of the committee, and that the member so appointed act as Chairman of the committee at any time when the Chairman is not present at a meeting of the committee.
  - (7) That the committee have power to appoint sub-committees consisting of three or more of its members and to refer to any such sub-committee any of the matters which the committee is empowered to examine.
  - (8) That the committee have power to send for persons, papers and records, to move from place to place and to sit during any recess or adjournment of the Parliament.
  - (9) That the committee have leave to report from time to time and that any member of the committee have power to add a protest or dissent to any report.
  - (10) That the committee may proceed to the despatch of business notwithstanding that all members of the committee have not been appointed and notwithstanding any vacancy on the committee.
  - (11) That five members of the committee constitute a quorum of the committee, and two members of a sub-committee constitute a quorum of that sub-committee.
  - (12) That in matters of procedure the Chairman or Deputy Chairman presiding at the meeting have a deliberative vote and, in the event of an equality of voting, have a casting vote, and that, in other matters, the Chairman or Deputy Chairman have a deliberative vote only.
  - (13) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
  - (14) That a message be sent to the Senate acquainting it of this resolution and requesting that it concur and take action accordingly.

Debate resumed.

Mr Calder moved, as an amendment—That after the words "report on" in paragraph (1) the following words be inserted: "the advancement of political responsibility and constitutional reform for the Legislative Council of the Northern Territory and".
