- 7 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—INDUSTRIAL DISPUTES—MINISTERIAL ATTITUDES: Mr Speaker informed the House that Mr Fraser had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The biased attitude of certain Ministers to industrial disputes".
