TUESDAY, 15 OCTOBER 1974

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Dr J. F. Cairns (Minister for Overseas Trade), Mr Gorton and Mr Jarman—from certain citizens of Australia praying that the Government immediately increase, as an interim measure, current grants made to children in non-government schools to at least 50 per cent of the cost of educating children in government schools.
 - Mr Jones (Minister for Transport), Dr Klugman and Mr Whan—from certain citizens of Australia praying that the Government hasten to introduce a universal health scheme so that health care services in Australia can function efficiently and economically.
 - Mr Lynch (Deputy Leader of the Opposition), Mr Keating and Mr Nixon—from certain citizens of Australia praying that the Government increase child endowment in the September Budget.
 - Mr Enderby (Minister for Manufacturing Industry)—from certain residents of the Australian Capital Territory praying that the House urge the Government not to proceed with the introduction of self-government for the Australian Capital Territory until the residents of the Territory are consulted, by means of a referendum, on the issue.
 - Mr Gorton—from certain citizens of Australia praying that the House ask the Australian Commission on Advanced Education to consider in its 1976–78 Triennium Report an allocation of funds for the provision of Union Facilities at the Royal Melbourne Institute of Technology.
 - Mr Keating—from certain citizens of Australia praying that the Government take no measures to interfere with existing television program standards or to permit easier entry into Australia, or production in Australia, of pornographic material.
 - Mr Lusher—from certain electors of the Division of Hume praying that greater consideration be given to those provisions of the Family Law Bill which could place in an unjust and unfair position a woman who performs in a praiseworthy manner her duties of wife, mother and home-maker.
 - Mr McLeay—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
 - Mr McLeay—from certain citizens of Australia praying that the Government cease the support of those organizations in southern Africa which are guilty of various acts of terrorism.

Cairns (Minister for Overseas Trade) and Mr Beazley (Minister for Education), Mr Bowen (Special Minister of State) was acting as Minister for Overseas Trade and was representing the Minister for Customs and Excise in this House and Mr Barnard (Minister for Defence) was acting as Minister for Education.

- 7 PARLIAMENTARY COMMITTEE SYSTEM—JOINT COMMITTEE: Mr Speaker informed the House of the following nominations of Senators and Members to be members of the Joint Committee on the Parliamentary Committee System:
 - Mr Berinson, Dr Jenkins, Mr Scholes and Mr Young had been nominated by the Prime Minister, Mr Fairbairn and Dr Forbes had been nominated by the Leader of the Opposition and Mr I. L. Robinson had been nominated by the Leader of the Australian Country Party.
 - Senators Gietzelt, McAuliffe and Mulvihill had been nominated by the Leader of the Government in the Senate, Senators Sir Magnus Cormack and Rae had been nominated by the Leader of the Opposition in the Senate and Senator Drake-Brockman had been nominated by the Leader of the Australian Country Party in that House.
- 8 ENVIRONMENT AND CONSERVATION—STANDING COMMITTEE: Mr Speaker informed the House that the Prime Minister had nominated Mr Morris to be a member of the Standing Committee on Environment and Conservation in place of Mr Sherry, resigned.

9 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—MINERALS AND ENERGY POLICIES: Mr Speaker informed the House that Mr Anthony (Leader of the Australian Country Party) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The confusion arising from the lack of publicly-stated minerals and energy policies, and the serious long-term consequences of this confusion for the nation".

The proposed discussion having received the necessary support-

Mr Anthony addressed the House.

Discussion ensued.

Mr Giles rising to address the House-

Mr Daly (Leader of the House) moved—That the business of the day be called on. Question—put and passed.

- 10 POSTPONEMENT OF BUSINESS: Ordered—That notice No. 1 and orders of the day Nos. 1 and 2, government business, be postponed until a later hour this day.
- 11 AUSTRALIAN SHIPPING COMMISSION BILL 1974: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question-put and passed-Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Clauses 1 to 12, by leave, taken together, and agreed to. Clause 13—

On the motion of Mr Nixon, the following amendment was made, after debate: Page 5, at the end of the clause add the following sub-section:

"(5) The Minister shall cause a copy of any direction given by him under subsection (1) to be laid before each House of the Parliament within 15 sitting days of that House after the direction is made by him.".

Clause, as amended, agreed to.

Clauses 14 and 15, by leave, taken together, and agreed to.

Clause 16—

On the motion of Mr Jones (Minister for Transport), the following amendment was made, after debate: Page 6, omit paragraph (c).

Clause, as amended, agreed to.

Clauses 17 and 18, by leave, taken together, and agreed to, after debate.

Clause 19-

On the motion of Mr Jones, the following amendment was made, after debate: Page 7, at the end of proposed section 36 add the following sub-sections:

"(4) The Commission is not a public authority for the purposes of paragraph (d) of section 23 of the *Income Tax Assessment Act* 1936–1974.

"(5) The Commission is not a public transport authority for the purposes of item 77 in the First Schedule to the Sales Tax (Exemptions and Classifications) Act 1935-1973.".

Clause, as amended, agreed to.

Clauses 20 to 22, by leave, taken together, and agreed to.

Schedule---

On the motion, by leave, of Mr Jones, the following amendments were made together: Paragraph 1, before "33 (3)" insert "30 (7),".

Paragraph 2, after "13 (4)," insert "30 (7),".

Schedule, as amended, agreed to.

Title agreed to. Bill to be reported with amendments.

The House resumed; Mr Scholes reported accordingly.

On the motion of Mr Jones, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

12 ADELAIDE TO CRYSTAL BROOK RAILWAY BILL 1974: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question-put and passed-Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Jones (Minister for Transport), the Bill was read a third time.

13 TARCOOLA TO ALICE SPRINGS RAILWAY BILL 1974: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question-put and passed-Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Jones (Minister for Transport), the Bill was read a third time.

- 14 APPROPRIATION BILL (No. 1) 1974-75-BUDGET DEBATE: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Snedden (Leader of the Opposition), viz.—That all words after "That" be omitted with a view to substituting the following words: "this House is of the opinion that the Budget fails to tackle Australia's economic crisis, in that:
 - (1) unemployment is permitted to grow and the prospect for school leavers is prejudiced,
 - (2) inflation is accelerated,
 - (3) existing poverty is ignored and new poverty is created,
 - (4) personal income tax is increased 45 per cent,
 - (5) living standards will be lowered,
 - (6) private enterprise is stifled,
 - (7) Government power is further centralised,
 - (8) individual incentive and thrift is penalised, and
 - (9) a double tax is levied on estates;
 - and because the Government:
 - (a) has made the Budget a socialist vehicle to intensify the attack on the States and break down the free enterprise system,
 - (b) believes the absurdity that the Government can spend without people paying or can build without people producing, and
 - (c) has preached private restraint but has threatened its achievement by its own Government extravagance"—

Debate resumed.

Adjournment negatived: It being half-past ten o'clock p.m.—The question was proposed— That the House do now adjourn.

Mr Daly (Leader of the House) requiring the question to be put forthwith without debate—

Question—put and negatived.

Question-That the words proposed to be omitted stand part of the question-put.
