WEDNESDAY, 16 OCTOBER 1974

- 1 The House met, at twelve o'clock noon, pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Erwin, Mr Fisher, Mr Macphee, Mr Mathews and Mr Nixon—from certain citizens of Australia praying that the House ask the Australian Commission on Advanced Education to consider in its 1976–78 Triennium Report an allocation of funds for the provision of Union Facilities at the Royal Melbourne Institute of Technology.
 - Mr Jones (Minister for Transport) and Dr Klugman—from certain citizens of Australia praying that the Government hasten to introduce a universal health scheme so that health care services in Australia can function efficiently and economically.
 - Mr Hodges and Mr McVeigh—from certain citizens of Australia praying that the Government take no measures to interfere with existing television program standards or to permit easier entry into Australia, or production in Australia, of pornographic material.
 - Mr Coates—from certain citizens of Australia praying that the House urge the Government (1) to grant at least \$10 million immediate emergency aid to the Sahelian region of Africa and continue to assist in the long term agricultural and social development of the region and (2) to take a leading part in initiatives to set up world food and fertilizer funds at the World Food Conference in November.
 - Mr Dawkins—from certain citizens of Australia praying that the House urge the Government to (1) justify existing relations with Indonesia, particularly the aid program and (2) examine ways to control private investment and to direct official aid so as to benefit the economically and politically weaker sections of the Indonesian people.
 - Mr Hodges—from certain citizens of Australia praying that the House not admit into the law of this land the principle that marriage is only temporary and the family no longer the fundamental unit of society.
 - Mr Hodges—from certain citizens of Australia praying that the House not proceed with the Human Rights Bill.
 - Mr Jarman—from certain citizens of Australia praying that the Government immediately increase, as an interim measure, current grants made to children in non-government schools to at least 50 per cent of the cost of educating children in government schools.
 - Mr Lusher—from certain electors of the Division of Hume praying that greater consideration be given to those provisions of the Family Law Bill which could place in an unjust and unfair position a woman who performs in a praiseworthy manner her duties of wife, mother and home-maker.
 - Mr MacKellar—from certain citizens of Australia praying that the House take action against the Government's decision to recognise the sovereignty of the Soviet Union over the Baltic States of Estonia, Latvia and Lithuania.

- Mr McLeay—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
- Mr Mathews—from certain electors of Australia praying that the House take immediate steps to restore education benefits to parents, at least to the 1973–74 level, either by increasing taxation deductions or through taxation rebates.
- Mr Millar-from certain citizens of Australia praying that the House not admit into the law of this land the Family Law Bill in its present form.
- Mr Morris—from certain citizens of Australia praying that the House pass the Family Law Bill without delay.
- Mr Nixon—from certain citizens of Australia praying that sub-clause 10 (3) of the Human Rights Bill 1973 be amended by adding the following words: "and no revenue derived in any way from any Australian citizen shall be appropriated by the Australian Government, or by a State Government, or by a Municipal Government, for the propagation or support of any religion".

- 3 QUESTIONS: Questions without notice were asked.
- 4 PAPERs: The following papers were presented, by command of His Excellency the Governor-General:

Australian Wine Board—Interim report for year 1973-74.

Demand for recreation workers—Report for the Department of Tourism and Recreation by C.P.S. Services, dated May 1974.

The following papers were presented, pursuant to statute:

Australian Wool Commission Act and Wool Industry Act—Australian Wool Commission—Reports and financial statements, together with the Auditor-General's Reports for year 1971–72 and period 1 July to 31 December 1972. Repatriation Act—Repatriation Commission—Report for year 1973–74.

5 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—TAXATION DEDUCTION FOR DEPENDENT EDUCATION EXPENSES: Mr Speaker informed the House that Mr Killen had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The indecisiveness of the Government's Budget decision to reduce the level of taxation deduction for dependent education expenses".

The proposed discussion having received the necessary support-

Mr Killen addressed the House.

Discussion ensued.

Discussion concluded.

6 SOCIAL SERVICES BILL (No. 3) 1974: Mr Hayden (Minister for Social Security), pursuant to notice, presented a Bill for an Act relating to Social Services. Bill read a first time.

Mr Hayden moved-That the Bill be now read a second time.

- Debate adjourned (Mr Chipp), and the resumption of the debate made an order of the day for the next sitting.
- 7 STATES GRANTS (SCHOOLS) BILL 1974: Mr Barnard (Acting Minister for Education), pursuant to notice, presented a Bill for an Act to Increase the Financial Assistance payable to the States in relation to Schools.

Bill read a first time.

Mr Barnard moved--That the Bill be now read a second time.

Debate adjourned (Mr Chipp), and the resumption of the debate made an order of the day for the next sitting.

8 NORTHERN TERRITORY (STABILIZATION OF LAND PRICES) BILL 1974: Dr Patterson (Minister for the Northern Territory), pursuant to notice, presented a Bill for an Act to Stabilize the Price of Land in the Northern Territory required, or likely to be required, in connexion with Urban Development. Bill read a first time.

Dr Patterson moved—That the Bill be now read a second time.

Debate adjourned (Mr Chipp), and the resumption of the debate made an order of the day for the next sitting.

9 LIVE-STOCK SLAUGHTER LEVY BILL 1974: Dr Patterson (Minister representing the Minister for Agriculture) presented a Bill for an Act to amend the *Live-stock Slaughter Levy* Act 1964–1973.

Bill read a first time.

Dr Patterson moved—That the Bill be now read a second time.

Debate adjourned (Mr Chipp), and the resumption of the debate made an order of the day for the next sitting.

10 LIVE-STOCK SLAUGHTER LEVY COLLECTION BILL 1974: Dr Patterson (Minister representing the Minister for Agriculture) presented a Bill for an Act to amend the *Live-stock Slaughter Levy Collection Act* 1964–1973.

Bill read a first time.

Dr Patterson moved-That the Bill be now read a second time.

Debate adjourned (Mr Chipp), and the resumption of the debate made an order of the day for the next sitting.

11 STEVEDORING INDUSTRY BILL 1974: Mr C. R. Cameron (Minister for Labor and Immigration), pursuant to notice, presented a Bill for an Act to amend section 7 of the *Stevedoring Industry Act* 1956–1973.

Bill read a first time.

Mr Cameron moved—That the Bill be now read a second time.

Debate adjourned (Mr Chipp), and the resumption of the debate made an order of the day for the next sitting.

12 REPATRIATION ACTS AMENDMENT BILL 1974: Mr Bowen (Minister representing the Minister for Repatriation and Compensation), pursuant to notice, presented a Bill for an Act relating to Repatriation and related Matters.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Debate adjourned (Mr Adermann), and the resumption of the debate made an order of the day for the next sitting.

13 CUSTOMS TARIFF PROPOSALS NO. 14 (1974): Mr Bowen (Minister representing the Minister for Customs and Excise) moved Customs Tariff Proposals No. 14 (1974).

Debate adjourned (Mr Adermann), and the resumption of the debate made an order of the day for the next sitting.

- 14 CONCILIATION AND ARBITRATION (ORGANIZATIONS) BILL 1974: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Mr Fraser who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the House is of opinion that the Bill should not be proceeded with until the Minister informs the House (a) whether or not the trade unions would accept the conditions for nonincorporated registration of State branches as laid down by the Honourable Mr Justice Sweeney and (b) of the position of the States concerning proposed complementary legislation".

Debate continued.

Debate adjourned (Mr Riordan), and the resumption of the debate made an order of the day for a later hour this day.

On the motion of Mr C. R. Cameron (Minister for Labor and Immigration), the House adopted the report.

Mr Cameron moved, by leave-That the Bill be now read a third time.

Mr Wentworth rising to address the House-

Question-That the question be now put-put and passed.

And the question—That the Bill be now read a third time—was put accordingly, and passed—Bill read a third time.

20 APPROPRIATION BILL (No. 1) 1974-75: The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.

- The House continuing to sit until eleven o'clock p.m.—Mr Speaker adjourned the House until tomorrow at ten o'clock a.m.
