TUESDAY, 19 NOVEMBER 1974

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Gorton, Mr Macphee and Mr Staley—from certain citizens of Australia praying that the House take immediate steps to restore education benefits to parents, at least to the 1973-74 level, either by increasing taxation deductions or through taxation rebates.
 - Mr Beazley (Minister for Education)—from certain citizens of Australia praying that the House promote debate to define and protect the different roles of husband and wife in full dignity.
 - Mr Ellicott—from certain citizens of Australia praying that the Government not proceed with the Family Law Bill in its present form.
 - Mr Fairbairn—from certain citizens of Australia praying that the Government forthwith return to the States all moneys raised by way of taxes and excise on petroleum products.
 - Mr Nicholls—from certain members of the academic staff of Salisbury College of Advanced Education praying that the House grant an immediate interim salary award to academic staff of Colleges of Advanced Education to restore lost wage relativity and account for inflation.
 - Mr Mulder—from certain citizens of Australia praying that the House amend the Family Law Bill in certain respects.
 - Mr McLeay—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
 - Mr Scholes—from certain citizens of the Commonwealth praying that the Family Law Bill be debated and passed as soon as possible.

8 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—GOVERNMENT SPENDING—PROPOSED REDUCTION: Mr Speaker informed the House that Mr Mathews had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "Deprivation and dislocation arising from a proposed 8 per cent 'across the board' reduction in government spending'.
