## MONDAY, 2 DECEMBER 1974

- 1 The House met, at fifteen minutes past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Dawkins, Mr McVeigh and Mr Staley—from certain citizens and foreign students in Australia praying that the House ensure the political and other rights of foreign students who study in Australia.
  - Dr Gun and Mr Staley—from certain citizens of Australia praying that the House take urgent steps to ensure that further mining and export from Australia of uranium, except for bio-medical purposes, be banned and that the Australian Atomic Energy Commission be transformed into an Australian Energy Commission.
  - Mr Bennett—from certain members of St Mary's Church of England Girls' School, Karrinyup, Western Australia praying that the House urge the Government to prevent the destruction of the Palace Hotel, St George's Terrace, Perth.
  - Mr Gorton—from certain citizens of Australia praying that the House take action against the Government's decision to recognise the sovereignty of the Soviet Union over the Baltic States of Estonia, Latvia and Lithuania.
  - Mr Lusher—from certain citizens of Australia praying that the Government take no measures to interfere with existing television program standards or to permit easier entry into Australia, or production in Australia, of pornographic material.
  - Mr McLeay—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
  - Mr Peacock—from certain citizens of the Commonwealth praying that the Family Law Bill be debated and passed as soon as possible.
  - Mr Peacock—from certain citizens of Australia praying that the House take immediate steps to restore education benefits to parents, at least to the 1973-74 level, either by increasing taxation deductions or through taxation rebates.
  - Mr Staley—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
  - Mr Staley—from certain citizens of Australia praying that the House reject the Human Rights Bill.
  - Mr Street—from certain citizens of Australia praying that the House make provision within the Family Law Bill for marriage guidance, legal assistance and research into marital instability.

13 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—DEFENCE SERVICES RESIGNATIONS: Mr Speaker informed the House that Dr Forbes had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The alarming rate of resignation of officers from the Services and the failure of the Government to implement defence policies which would remove the underlying cause of such resignations".

The proposed discussion having received the necessary support—

Dr Forbes addressed the House.

14 AGED PERSONS HOSTELS BILL 1974—SENATE'S AMENDMENT: The House, according to order, resolved itself into a committee of the whole to consider the amendment made by the Senate.

#### In the committee

#### SCHEDULE OF THE AMENDMENT MADE BY THE SENATE

Page 4, after clause 6, insert the following new clause:

"6A. Section 10 of the Principal Act is amended by omitting '3 years' and substituting '5 years'.".

On the motion of Mr Hayden (Minister for Social Security), the amendment was disagreed to, after debate.

Resolution to be reported.

The House resumed; Mr Scholes reported accordingly.

On the motion of Mr Hayden, the House adopted the report.

Mr Hayden moved—That Mr Daly (Minister for Services and Property), Mr Nicholls, and the mover be appointed a committee to draw up reasons for the House of Representatives disagreeing to the amendment of the Senate.

Question—put and passed.

Mr Hayden, on behalf of the committee, brought up such reasons, which were read, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendment of the Senate

Because the present Act has a further year to run and if it is desirable to consider extending the Act's period of operation, next year would be a more appropriate time, after the report on the currently conducted inquiry into aged persons accommodation programs has been received and considered by the Government.

Mr Hayden moved—That the committee's reasons be adopted. Question—put and passed.

15 ABORIGINAL LAND FUND BILL 1974: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed.

Question-put and passed-Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Bryant (Minister representing the Minister for Aboriginal Affairs), the Bill was read a third time.

16 STATES GRANTS (TECHNICAL AND FURTHER EDUCATION) BILL 1974: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Killen who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "while not denying this Bill a second reading, this House—

- (a) believes that the system as proposed by the Bill for the development of Technical and Further Education imposes intolerable and unacceptable administrative burdens upon the States and their educational systems;
- (b) deplores the fact that Parliament has had no opportunity to debate the Kangan Committee's report with regard to Technical and Further Education, and notes with concern the departure by the Government from the recommendations of the Committee:
- (c) asserts that the provisions of the Bill for the extensive use of Ministerial discretion will prove to be vexatious and will limit the States in their own educational programs;
- (d) contends that the grants proposed to be made to the States for the purposes proposed by the Bill should be made without being subject to the conditions as so prescribed, and
- (e) calls upon the Government to implement a scheme of grants to the States for Technical and Further Education that gives to the States control of expenditure of such grants and requires of them to report annually to the Minister as to the manner in which such grants have been expended".

Debate continued.
