9 INTER-STATE COMMISSION BILL 1975: The House, according to order, again resolved itself into a committee of the whole for the further consideration of the Bill.

In the committee

Clause 3 further considered.

Mr Nixon moved the following amendment: Page 2, lines 3 and 4, omit "or transport of goods that are the subject of such trade or commerce".

Debate continued.

Amendment negatived.

Clause agreed to.

Remainder of Bill, by leave, taken as a whole.

Mr Nixon, by leave, moved the following new clause and amendments together:

Proposed new clause-

Page 2, after clause 5 insert the following new clause:

"5A. Nothing in this Act or in any regulations made in pursuance of this Act will affect or authorise action in connection with the obligation of any of the parties under or the provisions or purposes of or the operations of the agreement referred to in sub-section 3 (4) of the Airlines Agreement Act 1952–1973 and the agreement referred to in sub-section 3 (3) of that Act as affected by the foregoing agreement and the agreement referred to in sub-section 3 (2) of that Act as affected by each of the foregoing agreements and the agreement referred to in sub-section 3 (1) of that Act as affected by each of the foregoing agreements.".

Amendments—

Clause 10, page 3, at the end of the clause add the following sub-clause:

"(2) Any adjudication by the Commission under sub-section (1) shall be by way of an order made by the Commission which shall be subject to the provisions of sections 46, 47 and 48 of the Acts Interpretation Act 1901–1973.".

Clause 13, page 4, omit the clause.

Clause 14-

Page 4, lines 21-25, omit all words after "Constitution" (first occurring), substitute "with respect to inter-State transport".

Page 4, omit paragraph (1) (d).

Page 5, omit sub-clause (11).
