that the House amend the Family Law Bill.

Mr McKenzie—from certain citizens of Australia praying that the House immediately revoke all Australian whaling licences and ban the importation of all whale produce.

Page 22, after sub-clause (1) insert the following sub-clause:

"(IA) A report referred to in sub-section (1) shall include details of the syllabuses and study undertaken at the College and at each of the Trade Union Training Centres."

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to.
