- 2. Messages from His Excellency the Governor-General.—The following Messages from His Excellency the Governor-General were presented, and the same were read by Mr. Speaker:—

#### NORTHCOTE,

Governor-General.

Message No. 3.

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of money be made for the purposes of a Bill for an Act to determine more definitely the seat of Government of the Commonwealth in the neighbourhood of Dalgety, and the territory there within which it shall be, and to provide for the grant to and acceptance by the Commonwealth of the territory, and to provide for other matters in relation thereto.

Message No. 4.

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of money be made for the purposes of a Bill for an Act to Authorize the Survey of Route for a Railway to connect Kalgoorlie, in the State of Western Australia, with Port Augusta, in the State of South Australia.
