TUESDAY, 24TH SEPTEMBER, 1907.

1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
2. PETITIONS.—Mr. Johnson presented a Petition from women electors of Kogarah and elsewhere, New South Wales, praying that the House will not pass the Tariff introduced on the 8th August, especially the items which render dearer, food, clothing, and other essentials used by the poorer classes.
Mr. Sinclair presented a Petition from teachers of music resident in the Moreton electorate, Queensland, praying that the proposed increased duties on pianos should not be agreed to.
Petitions severally received and read.
3. PAPERS.—Sir William Lyne presented, pursuant to the direction of an Act of Parliament—
Papua—Appropriation Ordinance—No. 8 of 1907.
Mr. Mauger presented, pursuant to the direction of an Act of Parliament—
Census and Statistics Act—Statistics of the Commonwealth—Trade and Customs and Excise Revenue 1906—Part II.
4. ALTERATION OF TIME OF NEXT MEETING.—Sir William Lyne moved, That the House, at its rising, adjourn until three o'clock to-morrow.
Question—put and resolved in the affirmative.
5. SUPPLY.—The House, according to Order, resolved itself into the Committee of Supply.
Mr. Speaker resumed the Chair; Mr. McDonald reported that a quorum of Members was not present in the Committee; whereupon Mr. Speaker counted the House, and a quorum of Members having been obtained, the House again resolved itself into the Committee.
Mr. Speaker again resumed the Chair; Mr. McDonald reported that the Committee had made progress and that he was directed to ask, That the Committee may have leave to sit again.
Resolved—That the House will, to-morrow, again resolve itself into the said Committee.
