1. The House met pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.

2. MURWILLUMBAH DISASTROUS FIRE .- Mr. Speaker informed the House that he had received a letter in reply to a telegram of sympathy which he had forwarded to Murwillumbah on behalf of the House. The letter was read by the Clerk, and is as follows :-

4. PETITION FROM ELECTORS OF HUME, NEW SOUTH WALES .- Mr. Hutchison moved, by leave, that the petition from electors of Hume, which was referred to the Printing Committee, be placed in their custody.

Question—put and resolved in the affirmative.

5. DOMINION OF NEW ZEALAND.-Mr. Deakin moved, by leave, That Mr. Speaker be requested, with the President of the Senate, to send a message conveying the congratulations and good wishes of the Commonwealth to New Zealand, on the occasion of the celebration of its assumption of the new title of "Dominion."

And other honorable Members having spoken in support of the motion-Question-put and resolved in the affirmative.

6. SUPPLY.—Pursuant to the provisions of Standing Order No. 241, the Order of the Day having been read for going into the Committee of Supply-Question-That Mr. Speaker do now leave the Chair-put and negatived.

Resolved-That the House will, this day, at a later hour, resolve itself into the said Committee.

7. JUDICIARY BILL (1907).—The Order of the Day having been read for the third reading of this Bill— Mr. Groom moved, That the Bill be now read a third time. Debate ensued.

Question-put and resolved in the affirmative.-Bill read a third time.

8. COMMONWEALTH SALARIES BILL .- The Order of the Day having been read for the second reading of this Bill-

Point of Order .-- Mr. Crouch submitted that the Bill was out of order, because it had been introduced in the Senate.

Speaker's Ruling .-- Mr. Speaker stated that the enacting clauses of the Bill indicated clearly that this was not a Bill either to appropriate revenue or moneys or to impose taxation within the meaning of section 53 of the Constitution, and that he therefore ruled without any hesitation that the Bill did not come within the prohibitions of section 53 and was properly before the House; that it was not improper for it to have originated where it did. The Bill in no sense levied taxation for the benefit of the Commonwealth Treasury.

Mr. Groom moved, That the Bill be now read a second time.

Debate ensued.

Question—put and resolved in the affirmative.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Speaker resumed the Chair; Mr. McDonald reported that the Committee had gone through the Bill and had agreed to the same with an amendment.

Mr. Groom moved, by leave, That the Standing Orders be suspended to enable the Bill to pass through all its remaining stages without delay.

Question—put and resolved in the affirmative.

Mr. Groom moved, That the Report from the Committee of the whole House on the Bill be now adopted.

Question—put and resolved in the affirmative.

Mr. Groom moved, That the Bill be now read a third time.

Question-put and resolved in the affirmative.-Bill read a third time.
