1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
2. MAIL SERVICE TO EUROPE—AGREEMENT WITH ORIENT COMPANY.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Mauger:—

That the House of Representatives approves the Agreement made and entered into the 15th day of November, 1907, between His Majesty's Postmaster-General in and for the Commonwealth of Australia of the first part, Orient Steam Navigation Company Limited of the second part, and the Law Guarantee and Trust Society Limited of the third part for the carriage of mails and services to be performed as therein provided, a copy of which Agreement has been laid upon the Table of the House—

*And on the following amendment proposed thereto by Mr. Thomas:—*That all the words after the word "Representatives" be omitted from the motion with a view to the insertion in place thereof of the words—"is of opinion that, in the best interests of the Commonwealth, the Government should purchase and control a fleet of mail steamers capable of maintaining a fortnightly mail service between Australia and Great Britain"—

Debate resumed.

Ordered—That the debate be resumed as soon as Message No. 19 from the Senate has been dealt with.

3. MESSAGE FROM THE SENATE.—SUPPLY BILL (No. 4) 1907–8.—Mr. Speaker announced the receipt of the following Message from the Senate:—

4. MESSAGE FROM THE SENATE.—BOUNTIES BILL (1907).—Mr. Speaker announced the receipt of the following Message from the Senate:—

MR. SPEAKER,

Message No. 19.

The Senate returns to the House of Representatives the Bill for "*An Act to provide for the Payment of Bounties on the Production of certain Goods,*" and acquaints the House of Representatives that the Senate does not insist upon its amendment No. 9, disagreed to by the House of Representatives.

The Senate agrees to the amendment of the House of Representatives upon its amendment No. 11, and to consequential amendment in amendment No. 2.

The Senate insists upon its amendment No. 7, disagreed to by the House of Representatives, as shown in the annexed Schedule, and requests the reconsideration of the Bill in respect to that amendment and to amendments Nos. 2 and 12, in which the Senate has made consequential amendments, as shown in the annexed Schedule.

5. MESSAGE FROM HIS EXCELLENCY THE GOVERNOR-GENERAL.—ASSENT TO BILL.—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker :—

Message No. 19.

A Bill intituled "*An Act to amend the Law relating to Parliamentary Elections and to provide for the Settlement of Questions relating to the Qualifications of Members of the Parliament and to Vacancies in either House of the Parliament*," as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.
