- 2. Message from His Excellency the Governor-General.—Assent to Bill.—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:—

A Bill intituled "An Act to grant and apply out of the Consolidated Revenue Fund a sum for the service of the year ending the thirtieth day of June One thousand nine hundred and eight" (Supply Act (No. 5) 1907-8), as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.

 Petition received and read.
- 5.
