UNITED STATES OF AMERICA—VISIT OF FLEET.—Mr. Deakin informed the House that the Governor-General had received the following cablegram from the Secretary of State: -- "My telegram of 2nd March and your telegram of 21st March please inform your Ministers United States Government gladly accept invitation for visit of Fleet, and highly appreciate friendly courtesy on the part of Commonwealth."
- 3. CANADIAN CELEBRATION AT QUEBEC .- Mr. Deakin read to the House a telegram conveying an invitation to him from the Canadian Government to be present, personally, or by representative, as a guest at the celebration to be held at Quebec in July next, and his reply thereto, and also a telegram from the Earl of Elgin stating that Lord Dudley, Governor-General elect, had accepted an invitation of the Commonwealth Government to represent Australia on the occasion.
- 4. PAPER.--Mr. Deakin presented, by command of His Excellency the Governor-General-

Colonial Office-Copy of Despatch from the Prime Minister of the Commonwealth, dated 19th November, 1907, relating to the organization of the Colonial Office.
