Message No. 26.

The Senate, having taken into consideration Message No. 24 of the House of Representatives, dated 2nd April, 1908, acquaints the House of Representatives that the Senate has agreed to the following resolutions:-

(1) That the Select Committee of the Senate appointed to inquire into and report upon procedure in cases of breach of privilege be empowered, jointly with the Select Committee similarly appointed by the House of Representatives, to inquire into and report upon any recent allegations reflecting upon Parliament or any of the Members thereof, and for such purposes to exercise all such powers as have been conferred by this Senate.

(2) That a Message be sent to the House of Representatives conveying the above Resolution.
