- 1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. PAPERS.—Mr. Thomas presented, by command of His Excellency the Governor-General—

3. ELECTORAL BILL (1908).—Mr. Mahon, pursuant to leave given on the 27th ultimo, brought up a Bill intituled "A Bill for an Act to amend the Law relating to Parliamentary Elections," and moved, That it be now read a first time.

Question—put and resolved in the affirmative.—Bill read a first time.

- Ordered—That the second reading be made an Order of the Day for to-morrow.
- 4. PARLIAMENTARY WITNESSES BILL.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Speaker resumed the Chair; Mr. McDonald reported that the Committee had made progress in the Bill, and that he was directed to ask, That the Committee may have leave to sit again. Resolved—That the House will, to-morrow, again resolve itself into the said Committee.

- 5. Supply.—The House, according to Order, resolved itself into the Committee of Supply. Mr. Speaker resumed the Chair; Mr. McDonald reported that the Committee had made progress, and that he was directed to ask, That the Committee may have leave to sit again. Resolved—That the House will, to-morrow, again resolve itself into the said Committee.
- 6. ADJOURNMENT.—Mr. Fisher moved, That the House do now adjourn. Question—put and resolved in the affirmative.

And then the House, at three minutes to eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
