#### THURSDAY, 6 MAY 1976

- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Adermann (Minister for the Northern Territory), Mr Connolly, Mr Fisher, Mr Fry and Mr Willis—from certain citizens of Australia praying that a Commission of Inquiry be initiated into the Aurukun Associates Agreement Act, no mining take place on the Aurukun Aboriginal Reserve until a full environmental impact study has been made and an export licence to the consortium concerned be refused until negotiations are held with the Aurukun people and an agreement has been reached.
  - Mr Bradfield and Mr Hurford—from certain citizens of Australia praying that the Australian delegation to the fourth session of UNCTAD be instructed to support the principle of an integrated program of commodities and take certain other action.
  - Mr Bradfield and Dr Klugman—from certain citizens of Australia praying that the right of all trade union members to participate in ballots be guaranteed, voting in union elections be made compulsory and re-introduction of the collegiate system of union elections be resisted.
  - Dr J. F. Cairns and Mr Falconer—from certain citizens of Australia praying that the Australian Assistance Plan be continued as recommended in the report tabled in Parliament on 4 March 1976.
  - Mr Chapman and Mr Fry—from certain citizens of Australia praying that the Government reverse the decision to cut 1975–76 overseas development assistance, reaffirm Australia's commitment of assistance of a minimum of 0.7% of G.N.P. and establish an independent statutory authority to administer such assistance.
  - Mr J. L. McMahon and Mr Morris—from certain citizens of Australia praying that milk substitutes for children up to 6 years of age be restored to the schedule of pharmaceutical benefits.
  - Mr Bonnett—from certain members of the staff of Pimlico State High School, Qld, praying for continuing financial support from the Commonwealth Government for education.
  - Mr Carige—from certain citizens of Australia praying that the Cadet forces be re-instated.
  - Mr Carige—from certain citizens of Australia praying that the Australian Assistance Plan be continued as a longer term program on a regional basis.
  - Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.

- Mr Connolly—from certain citizens of Australia praying that the export of mineral sands from Fraser Island be prohibited and the Queensland Government and other bodies be assisted to develop and conserve the natural environment of the Island.
- Mr Fry—from certain citizens of Australia praying that the Australian Heritage Commission be appointed urgently and grants be given to community organisations concerned with conservation.
- Mr Fry and Dr Jenkins—from certain members of the Society for Growing Australian Plants (Canberra Region) and the Warringal Conservation Society, Heidelberg, Vic., respectively, in terms similar to the last preceding petition.
- Mr Fry—from certain citizens of Australia praying that the Australian National Library be accessible to readers from 9.30 a.m. to 10.00 p.m. daily.
- Mr L. K. Johnson-from certain citizens of Australia praying that no measures be taken to interfere with the Schools Commission.
- Mr L. K. Johnson-from certain citizens of Australia praying that any proposal to build an Omega station on Australian soil be rejected.
- Dr Klugman—from certain citizens of Australia praying that the introduction of television and radio licence fees, the imposition of a tax levy for Medibank and the introduction of higher charges for drugs dispensed under the pharmaceutical benefits scheme be prevented.
