No. 29 WEDNESDAY, 19 MAY 1976

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Sinclair (Minister for Primary Industry), Mr Viner (Minister for Aboriginal Affairs), Mr Brown, Mr Connolly, Mr Hyde, Mr Morris, Mr Ruddock and Mr Wallis—from certain citizens of Australia praying that a Commission of Inquiry be initiated into the Aurukun Associates Agreement Act, no mining take place on the Aurukun Aboriginal Reserve until a full environmental impact study has been made and an export licence to the consortium concerned be refused until negotiations are held with the Aurukun people and an agreement has been reached.
 - Mr Armitage, Mr Goodluck, Mr Hurford, Mr Innes, Mr Morris and Mr Porter—from certain citizens of Australia praying that the Government reverse the decision to cut 1975–76 overseas development assistance, reaffirm Australia's commitment of assistance of a minimum of 0.7% of G.N.P. and establish an independent statutory authority to administer such assistance.
 - Mr Anthony (Minister for National Resources) and Mr Ruddock—from certain citizens of Australia praying that the Australian delegation to the fourth session of UNCTAD be instructed to support the principle of an integrated program of commodities and take certain other action.
 - Mr D. M. Cameron and Mr Haslem—from certain citizens of Australia praying that the Australian Heritage Commission be appointed urgently and grants be given to community organisations concerned with conservation.
 - Mr Ruddock—from certain members of the Sydney University Conservation Society in terms similar to the last preceding petition.
 - Mr Brown—from certain citizens of Australia praying that the Australian Assistance Plan be continued as recommended in the report tabled in Parliament on 4 March 1976.
 - Mr Carige—from certain citizens of Australia praying that the Cadet forces be re-instated.
 - Mr Connolly—from certain citizens of Australia praying that the export of mineral sands from Fraser Island be prohibited and the Queensland Government and other bodies be assisted to develop and conserve the natural environment of the Island.
 - Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.
 - Mr Connor—from certain citizens of Australia praying that the Australian Assistance Plan be supported.
 - Mr Corbett—from certain citizens of Australia praying that the Australian Assistance Plan be continued as a longer term program on a regional basis.
 - Mr Garrick—from certain citizens of Australia praying that no measures be taken to interfere with the Schools Commission.

Mr Innes—from certain students and staff of State Colleges of Victoria praying that the Tertiary Education Assistance Scheme allowance be raised from \$30 to \$48 per week.

Mr Jacobi—from certain citizens of Australia praying that the Health Insurance Act be not amended.

Mr J. L. McMahon—from certain citizens of Australia praying that at least 0.55% of Australia's G.N.P. be provided in the next Budget for aid to poor countries.

Mr J. L. McMahon—from certain citizens of Australia praying that milk substitutes for children up to 6 years of age be restored to the schedule of pharmaceutical benefits.

Mr Morris—from certain citizens of Australia praying that a system of double income tax on personal incomes be not re-introduced.

3 Suspension of standing orders—Motion of censure of Government: Mr E. G. Whitlam (Leader of the Opposition) having given a notice of motion—

Mr Fraser (Prime Minister) informed the House that he accepted the notice of motion as a motion of censure of the Government for the purposes of standing order 110.

Mr Fraser, by leave, moved—That so much of the standing orders be suspended as would prevent Mr E. G. Whitlam moving forthwith the motion of censure of the Government of which he has given notice for the next sitting.

Question—put and passed.

4 MOTION OF CENSURE OF GOVERNMENT: Mr E. G. Whitlam (Leader of the Opposition) moved—That this House censures the Government, the Prime Minister and senior Cabinet Ministers for their involvement in loan inquiries by State Ministers and representatives in breach of their undertaking that there would be no inquiries during the election campaign into the activities of the previous Government.

On the motion of Mr E. L. Robinson (Minister Assisting the Treasurer), the Bill was read a third time.

15 STEVEDORING INDUSTRY CHARGE AMENDMENT BILL 1976: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Street (Minister for Employment and Industrial Relations), the Bill was read a third time.

- 16 INCOME TAX ASSESSMENT AMENDMENT BILL 1976: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Mr Hurford who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House notes that:
 - (a) the legislation involves the breaking of election promises with the removal for many of home mortgage interest deductions and the inadequate alterations to winemakers' tax liability and
 - (b) the provisions for the introduction of the investment allowance have created a chaotic situation in the economy".

Debate continued.

Mr Armitage addressing the House-
