THURSDAY, 17 FEBRUARY 1977

1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.

2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr C. R. Cameron, Mr Drummond, Mr McVeigh and Mr Millar—from certain citizens praying that the recommendations of the Australian Council of Local Government Associations for the allocation of funds for roads be adopted and the Government's long-term policy be to provide 50 per cent of all funds for roads.

Mr Connolly, Mr Dobie, Mr Jarman and Mr Martin—from certain citizens praying that the continuation and growth of symphony orchestras throughout Australia be ensured.

Mr Connolly and Mr Lucock—from certain citizens praying that the recommendations of the Commonwealth Bureau of Roads for the funding of local roads in New South Wales be adopted.

Mr Baume—from certain citizens praying that public telephones be provided in the Minto Housing Commission Estate, N.S.W.

Mr Groom—from certain citizens praying that the House voice its disapproval of the arrest and detention of certain Czech citizens, contrary to the United Nations Declaration of Human Rights.

Mr Wilson—from certain citizens praying that superannuation pensions be tax free.

10 DEFENCE FORCE (RETIREMENT AND DEATH BENEFITS AMENDMENTS) BILL 1977: Mr McLeay (Minister Assisting the Minister for Defence), for Mr Killen (Minister for Defence), pursuant to notice, presented a Bill for an Act relating to Retirement and Death Benefits for Members of the Defence Force.

Bill read a first time.

Mr McLeay moved—That the Bill be now read a second time.

Debate adjourned (Mr Connor), and the resumption of the debate made an order of the day for the next sitting.
