#### SECOND SESSION OF THE THIRTIETH PARLIAMENT

## TUESDAY, 8 MARCH 1977

- 1 Members of the House assembled at 3 p.m., pursuant to the Proclamation of His Excellency the Governor-General, dated 28 February 1977. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair.
- 2 PROCLAMATION BY THE GOVERNOR-GENERAL: The Proclamation by His Excellency the Governor-General, dated 28 February 1977, was read at the Table by the Clerk, as follows:

#### **PROCLAMATION**

JOHN R. KERR
Governor-General.

By His Excellency the Governor-General of the Commonwealth of Australia

Whereas by the Constitution of the Commonwealth of Australia it is amongst other things provided that the Governor-General may appoint such times for holding the sessions of the Parliament as he thinks fit, and may also, from time to time, by Proclamation or otherwise, prorogue the Parliament:

Now therefore, I, Sir John Robert Kerr, the Governor-General aforesaid, do by this my Proclamation prorogue the Parliament until Tuesday, 8 March 1977 or (in the event of circumstances arising, at present unforeseen, which render it expedient that the Parliament should be summoned to assemble on a day earlier than that day) to such earlier day as is fixed by a Proclamation summoning the Parliament to assemble and be holden for the despatch of business:

Furthermore I do appoint the said Tuesday, 8 March 1977, or such earlier day (if any) as is fixed by Proclamation, as the day for the Parliament to assemble and be holden for the despatch of business:

And all Senators and Members of the House of Representatives are hereby required to give their attendance accordingly in the building known as Parliament House, Canberra, at the hour of three o'clock in the afternoon, on Tuesday, 8 March 1977 or, in the event of an earlier day being fixed by Proclamation, at the time fixed by that Proclamation on the day so fixed.

4 Message from Her Majesty The Queen by the Usher of the Black Rod: The following message was delivered by the Usher of the Black Rod:

6 HER MAJESTY THE QUEEN'S SPEECH: Mr Speaker reported that the House had that day attended Her Majesty The Queen in the Senate Chamber, when Her Majesty was pleased to make a Speech to both Houses of the Parliament, and that he had received a copy.

Mr Speaker presented the copy of the Speech. (Text of the Speech appears in Hansard)

7 ADDRESS IN REPLY TO THE SPEECH OF HER MAJESTY THE QUEEN: Mr Fraser (Prime Minister) moved—That a committee, consisting of Mr Groom, Mr MacKenzie and the mover be appointed to prepare an Address in Reply to the Speech delivered by Her Majesty The Queen to both Houses of the Parliament, and that the committee do report at the next sitting.

Question-put and passed.

8 ADJOURNMENT: Mr Sinclair (Leader of the House) moved—That the House do now adjourn.

Question—put and passed.

And then the House, at 3.28 p.m., adjourned until tomorrow at 2.30 p.m.
