## TUESDAY, 15 MARCH 1977

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 DEATH OF FORMER SENATOR (THE HONOURABLE J. I. ARMSTRONG): Mr Fraser (Prime Minister) referred to the death of the Honourable J. I. Armstrong, and moved—That this House expresses its deep regret at the death on 10 March of the Honourable John Ignatius Armstrong, A.C., a Senator for New South Wales from 1938 to 1962, a Minister of the Crown from 1946 to 1949, Deputy Opposition Leader in the Senate from 1951 to 1956, Lord Mayor of Sydney from 1965 to 1967, and High Commissioner for Australia to the United Kingdom from 1973 to 1975; places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his widow and family in their bereavement.
  - And Mr E. G. Whitlam (Leader of the Opposition) having seconded the motion, and Mr Anthony (Leader of the National Country Party of Australia), Mr Speaker and other honourable Members having addressed the House in support thereof, and all Members present having risen, in silence—
  - Question—passed.

  - Mr Anthony—from certain members of the Order of the White Cross praying that certain steps be taken to encourage afforestation.
  - Mr Beazley—from certain citizens praying that the means test on all aged pensions be abolished.
  - Mr Braithwaite—from certain citizens praying that the zone allowance provisions in the Income Tax Assessment Act be varied.
  - Mr Braithwaite—from certain citizens praying that an Australian Broadcasting Commission television service be established at Moranbah, Qld.
  - Mr Haslem—from certain citizens praying that a Citizens Radio Service be allowed to function legally.

Mr Jarman—from certain citizens praying that the imperial system of weights and measures be restored.

Mr King—from certain councillors and residents of the Shire of Kowree, Vic., praying that the Government totally finance national highways and provide half the cost of all other public roads.

Mr Morris—from certain citizens praying that a system of double income tax on personal incomes be not re-introduced.

Mr Shipton—from certain citizens praying that an organisation concerned with better quality television for children be created.

Mr Uren—from certain citizens praying that the recommendations of the Committee of Inquiry into Public Libraries be implemented.

Mr Young—from certain citizens praying that the Australian Assistance Plan be continued.

- 7 ABORIGINAL LAND RIGHTS IN THE NORTHERN TERRITORY—JOINT SELECT COMMITTEE: Mr Speaker informed the House of the following nominations of Senators and Members to be members of the Joint Select Committee on Aboriginal Land Rights in the Northern Territory:

Government Ministers' misleading statements on the economy".

The proposed discussion having received the necessary support—

Mr Hurford addressed the House.

11 Address in Reply to the Speech of Her Majesty The Queen: The order of the day having been read for the resumption of the debate on the question—That the following Address in Reply to the Speech of Her Majesty The Queen be agreed to:

MOST GRACIOUS SOVEREIGN:

We, Your Majesty's loyal subjects, the Members of the House of Representatives of the Commonwealth of Australia, in Parliament assembled, desire to thank Your Majesty for the Gracious Speech which you have been pleased to address to Parliament.

The presence in Australia of Your Majesty and of His Royal Highness The Duke of Edinburgh has once again brought the greatest pleasure to Your Australian people. We, their representatives in this House, are grateful for the opportunity to re-affirm our allegiance to you as our Queen.

Debate resumed.

Debate adjourned (Mr Drummond), and the resumption of the debate made an order of the day for a later hour this day.

12 FOREIGN POLICY—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Peacock (Minister for Foreign Affairs), by leave, made a ministerial statement with respect to the Government's foreign policy, and, by command of His Excellency the Governor-General, presented the following paper:

Foreign policy-Ministerial statement, 15 March 1977.
