### THURSDAY, 24 MARCH 1977

- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 Peritions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Braithwaite, Mr Carige, Mr Chapman, Mr Groom, Mr Katter and Mr McVeigh—from certain citizens praying that the Government's long-term policy be to provide 50 per cent of funds for roads.
  - Mr Fry, Dr Klugman and Mr MacKenzie—from certain members of the Service Station Association of N.S.W. Ltd and others praying that in implementing the findings of the Royal Commission on Petroleum the needs of the motoring public and retail petroleum industry be given every consideration.
  - Mr Graham and Dr Klugman—from certain citizens praying that increases in the Consumer Price Index be applied to pensions and that future pensions not be reduced as a result of any revision of the Index.
  - Mr Bradfield—from certain citizens praying that the recommendations of the Commonwealth Bureau of Roads for the funding of local roads in New South Wales be adopted.
  - Mr Braithwaite—from certain citizens praying that the zone allowance provisions in the Income Tax Assessment Act be varied.
  - Mr Braithwaite—from certain citizens praying that an Australian Broadcasting Commission television service be established at Moranbah, Qld.
  - Mr Braithwaite—from certain citizens praying that the Australian Assistance Plan be financed on a national basis and administered by State Governments.
  - Mr Ellicott-from Danny Sankey of Vaucluse, N.S.W., solicitor, praying that the House (1) grant leave to the petitioner, his legal representatives, the presiding Magistrate and the legal representatives for the defendants appearing at the Queanbeyan Court of Petty Sessions to look at and have marked for identification the documents already produced to that Court on 21 December 1976 by the then Clerk of this House and otherwise to use and deal with those documents in order to establish as a fact that such documents were tabled in this House on 9 July 1975 and are copies of original documents now held in the custody of the Commonwealth Crown and (2) grant leave to the petitioner and his legal representatives to issue and serve subpoenae for the attendance at the Queanbeyan Court of Petty Sessions to give evidence, of all those persons who took the official record of that part of the proceedings of this House on 9 July 1975 where the Honourable Edward Gough Whitlam, Q.C., and the Honourable Reginald Francis Xavier Connor stated the purposes of the proposed overseas borrowing and in particular to give evidence of the matters stated by those two honourable Members as appear in the House of Representatives Weekly Hansard No. 12, 1975 at pages 3595-6, 3598-9 and 3611-2.

Mr Fry—from certain citizens praying that any legislation to extend the power to compulsorily retire Australian Government employees be rejected unless it has the approval of staff representatives.

Mr Gillard—from certain citizens praying that the decision to cut the 1975-76 Overseas Development Assistance vote be reversed and other action be taken concerning overseas development assistance.

Mr McVeigh—from certain citizens praying that the petrol price equalisation scheme be restored.

- 8 Message from the Senate—Referendum (Constitution Alteration) Modification Bill 1977: Message No. 2, dated 23 March 1977, from the Senate was reported transmitting for the concurrence of the House a Bill for "An Act to modify the application of section 16 of the 'Referendum (Constitution Alteration) Act 1906'".

Mr Ellicott (Attorney-General) moved—That the Bill be now read a second time. Debate adjourned (Mr Bowen), and the resumption of the debate made an order of the day for the next sitting.

9 CRIMINAL INVESTIGATION BILL 1977: Mr Ellicott (Attorney-General), pursuant to notice, presented a Bill for an Act relating to the Investigation of Offences against the Laws of the Commonwealth and of the Internal Territories by Members of the Commonwealth Police Force, and for Purposes connected therewith.

Bill read a first time.

Mr Ellicott moved—That the Bill be now read a second time.

Debate adjourned (Mr Bowen), and the resumption of the debate made an order of the day for the next sitting. 10 LAW COURTS (SYDNEY) BILL 1977: Mr Ellicott (Attorney-General), pursuant to notice, presented a Bill for an Act relating to the Transfer of certain Land in Sydney to Law Courts Limited and the exemption of that Company from certain Taxation.
