TUESDAY, 29 MARCH 1977

1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.

2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Braithwaite, Mr Burr, Mr Carige and Mr Giles—from certain citizens praying that the Government's long-term policy be to provide 50 per cent of funds for roads.

Dr Klugman, Mr I. L. Robinson and Mr A. P. Whitlam—from certain citizens praying that increases in the Consumer Price Index be applied to pensions and that future pensions not be reduced as a result of any revision of the Index.

Dr Klugman and Mr Lusher—from certain members of the Service Station Association of N.S.W. Ltd and others praying that in implementing the findings of the Royal Commission on Petroleum the needs of the motoring public and the retail petroleum industry be given every consideration.

Mr Braithwaite—from certain citizens praying that the zone allowance provisions in the Income Tax Assessment Act be varied.

Mr Braithwaite—from certain citizens praying that an Australian Broadcasting Commission television service be established at Moranbah, Qld.

Mr Lloyd—from certain citizens praying that the Government totally finance national highways and provide half the cost of all other public roads.

Mr McVeigh—from certain citizens praying that the petrol price equalisation scheme be restored.

Mr McVeigh—from certain Commonwealth public servants praying that there be no interference with holiday pay loading, maternity leave and staff ceiling provisions in the Commonwealth Public Service.

Mr Wallis—from certain citizens of Eyre Peninsula, S.A., praying that television services be provided to the area.

- 6 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—URANIUM DEBATE: Mr Speaker informed the House that Mr E. G. Whitlam (Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The Fraser Government's efforts to pre-empt and distort the uranium debate".

The proposed discussion having received the necessary support—

Mr E. G. Whitlam addressed the House.

Discussion ensued.

- 7 ASIAN DEVELOPMENT BANK (ADDITIONAL SUBSCRIPTION) BILL 1977: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

*Message from the Governor-General:* Message No. 2, dated 17 March 1977, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Viner (Minister Assisting the Treasurer), the Bill was read a third time.

- 8 REFERENDUM (CONSTITUTION ALTERATION) MODIFICATION BILL 1977: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Ellicott (Attorney-General), the Bill was read a third time.

- 9 CRIMES (FOREIGN INCURSIONS AND RECRUITMENT) BILL 1977: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Bowen who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the Bill be withdrawn and redrafted to prevent—

(a) hostile incursions by Australians into foreign countries;

(b) preparations for such incursions, and

(c) recruitment in Australia of Australian citizens for these purposes".

Debate continued.
