WEDNESDAY, 4 MAY 1977

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Cohen, Mr L. K. Johnson and Mr I. L. Robinson—from certain citizens praying that increases in the Consumer Price Index be applied to pensions and that future pensions not be reduced as a result of any revision of the Index.
 - Mr Bradfield and Mr Cohen—from certain members of the Service Station Association of N.S.W. Ltd and others praying that in implementing the findings of the Royal Commission on Petroleum the needs of the motoring public and the retail petroleum industry be given every consideration.
 - Mr Chipp and Mr L. K. Johnson—from certain citizens praying that any legislation to extend the power to retire compulsorily Australian Government employees be rejected unless it has the approval of staff representatives.
 - Mr Braithwaite—from certain citizens praying that private clinics be prevented from performing abortions in the A.C.T. and that abortions not be financed through Medibank.
 - Mr Cohen—from certain citizens praying that Australian Government support for the Australian Assistance Plan be continued.
 - Mr Garrick—from certain citizens praying that a referendum be held on the question of the mining and export of uranium.
 - Mr Goodluck—from certain members of Parents Without Partners (Australia) Inc. and others praying that lone fathers receive a pension on the same basis as supporting mothers.
 - Mr Hodgman-from certain citizens praying that steps be taken to end commercial whaling.
 - Mr Innes-from certain citizens and residents from overseas praying that political asylum be granted to Mr Hishamuddin Rais.
 - Mr Morris—from certain citizens praying that the House call on Sir John Kerr to resign as Governor-General.
 - Mr Peacock—from an elector of the Division of Kooyong praying that the Income Tax Assessment Act be amended and certain other action be taken in connection with taxation matters.
 - Mr Short—from certain citizens praying that education expenditure be increased and certain other action be taken in connection with student assistance.

Mr Wallis—from certain citizens of Eyre Peninsula, S.A., praying that an automatic telephone service be introduced to the township and district of Port Neill, S.A. Petitions received.

- 3 NOTICES OF MOTION—STATEMENT BY MR SPEAKER: Mr Speaker made a statement regarding the form in which notices of motion should be given.
- 4 QUESTIONS: Questions without notice were asked.

5 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—FOREIGN INTELLIGENCE SERVICES IN AUSTRALIA: Mr Speaker informed the House that Mr E. G. Whitlam (Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The need for Parliamentary scrutiny of foreign intelligence services in Australia".

The proposed discussion having received the necessary support-

Mr E. G. Whitlam addressed the House.

Discussion ensued.

Discussion concluded.

6 INCOME TAX ASSESSMENT AMENDMENT BILL 1977: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Clauses 1 to 4, by leave, taken together, and agreed to. Clause 5---

On the motion of Mr Viner (Minister Assisting the Treasurer), the following amendment was made, after debate: Page 2, line 29, omit "whether before or after the commencement of this section", substitute "on or after 21 April 1977".

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole.

On the motion of Mr Viner, by leave, the following amendments were made together: Clause 18—

Page 16, line 8, omit "6,".

Page 16, omit sub-clause (4), substitute the following sub-clause:

"(4) The amendment made by section 6 does not apply in relation to a change in ownership or interests that occurred before 21 April 1977.".

Remainder of Bill, as amended, agreed to.

Bill to be reported with amendments.

The House resumed; Mr Lucock reported accordingly.

On the motion of Mr Viner, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

7 INCOME TAX (COMPANIES AND SUPERANNUATION FUNDS) AMENDMENT BILL 1977: The order of the day having been read for the resumption of the debate on the question— That the Bill be now read a second time—

Question-put and passed-Bill read a second time.

Leave granted for third reading to be moved forthwith.

- On the motion of Mr Viner (Minister Assisting the Treasurer), the Bill was read a third time.
