- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 RESIGNATION OF MEMBER: Mr Speaker announced that on 30 September 1977 he had received a letter from Mr Martin Henry Nicholls resigning his seat as Member for the Electoral Division of Bonython.
- 3 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Cadman, Dr Edwards, Mr Hunt, Mr Keating, Mr Sainsbury, Mr Stewart and Mr Wentworth—from certain citizens praying that the Broadcasting and Television Act be amended in relation to program standards.
 - Mr Bowen, Mr Martyr and Mr Sullivan—from certain citizens praying for the reversal of the decision withdrawing financial assistance from students of non-State tertiary institutions.
 - Mr Hamer—from certain students in the same terms as the last preceding petition.
 - Mr L. R. Johnson, Dr Klugman, Mr MacKenzie and Mr Sullivan—from certain citizens praying that private nursing homes be subsidised to allow pensioner patients to retain \$6 per week for personal use and that certain other action be taken in connection with pensioner benefits.
 - Mr Burr—from certain citizens praying for an indefinite ban on the mining of uranium.
 - Mr L. R. Johnson—from certain citizens praying that public debate on a replacement constitution be encouraged, a directly elected constitutional convention be convened and a referendum be conducted on any of its resolutions.
 - Mr Keating—from certain citizens praying that the part of a deceased person's estate which passes to the surviving spouse be free from federal estate duty.
 - Dr Klugman—from certain members of the Service Station Association of N.S.W. Ltd and others praying that in implementing the findings of the Royal Commission on Petroleum the needs of the motoring public and the retail petroleum industry be given every consideration.
 - Mr Lloyd—from certain citizens praying that photographs and blood groupings be included on driving licences.
 - Mr J. L. McMahon—from certain residents of Sydney praying that the interest rate on loans to State housing organisations not be increased.
 - Mr Wilson—from certain electors of the Division of Sturt praying that recipients of unemployment benefits be required to be available for a period of community service.

4 MINISTERIAL ARRANGEMENTS: Mr Fraser (Prime Minister) informed the House of the following ministerial arrangements during the respective absences abroad of Mr Peacock (Minister for Foreign Affairs), Mr McLeay (Minister for Construction) and Mr Howard (Minister for Special Trade Negotiations):

Mr Sinclair (Minister for Primary Industry) was acting as Minister for Foreign Affairs;

Mr Staley (Minister for the Capital Territory) was acting as Minister for Construction;

Senator Cotton (Minister for Industry and Commerce) was acting as Minister for Special Trade Negotiations and Mr Macphee (Minister for Productivity) was representing the Acting Minister for Special Trade Negotiations in this House;

Mr Anthony (Minister for Overseas Trade) would act as Minister for Special Trade Negotiations on his return from abroad, and

Mr Viner (Minister for Aboriginal Affairs) was representing the Minister for Industry and Commerce and Mr Macphee was representing the Attorney-General in this House.

5 Suspension of standing orders—Motion of censure of Member for Oxley: Mr Hodgman having given a notice of motion of censure of the honourable Member for Oxley—

Mr Scholes, by leave, moved—That so much of the standing orders be suspended as would prevent the honourable Member for Denison proceeding with his motion forthwith.

Mr Hayden addressing the House—

Closure: Mr Sinclair (Leader of the House) moved—That the question be now put. Question—That the question be now put—put and passed.

And the question—That the motion be agreed to—was put accordingly, and passed.

6 Member for Oxley (Mr Hayden)—Resolution of censure: Mr Hodgman moved—That this House censures the honourable Member for Oxley for his recent economically subversive public statements which, contrary to the accepted traditions of the Parliament, speculated upon the standing and strength of the Australian dollar, upon which the economy of this nation is based; encouraged the likelihood of a major capital outflow from Australia as the direct result of his persistent predictions of an impending devaluation; and as a result sought to damage Australia's economic and financial credibility in the eyes of the world at a time when the honourable Member for Oxley knew or ought to have known that Australia was in the process of negotiating for overseas loans.

Debate ensued.
