TUESDAY, 1 NOVEMBER 1977

1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.

2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

McMahon, Mr Neil and Mr Ruddock—from certain citizens praying for a guarantee of interim funding for, and a review of the position of, non-State business colleges and the reversal of the decision withdrawing financial assistance from students of such colleges.

Mr Baume, Mr Fife, Mr FitzPatrick and Mr Morris—from certain volunteer firemen of the New South Wales Fire Brigade Service praying that income tax relief be provided on the earnings of N.S.W. volunteer firemen.

Mr Armitage—from certain citizens praying that the Broadcasting and Television Act be amended in relation to program standards.

Mr Dobie—from certain citizens praying that expenditure on welfare, health and public education be maintained or increased.

Mr Innes—from certain citizens praying that the mining, selling and export of uranium be not permitted.

Mr Morris—from certain citizens praying that private nursing homes be subsidised to allow pensioner patients to retain \$6 per week for personal use and that certain other action be taken in connection with pensioner benefits.

Mr Wentworth—from certain electors praying that the House facilitate action to restore to the Notice Paper the notice of motion given on 6 May 1976 by the honourable Member for Mackellar, and that the matter be dealt with before the forthcoming dissolution of the House.

Mr Yates—from certain citizens praying that the responsibility to export uranium be emphasised, uranium be made available to those countries which need it and meet requirements and radical minorities be not permitted to over-rule government decisions.

(c) by omitting from column 3 of the table in sub-section (2):

‘In respect of 1 such child—\$226

In respect of each other such child—\$170’

and substituting:

‘In respect of each such child—\$50’.”

Debate ensued.

Mr Wentworth rising to address the committee—

Question—That the question be now put—put and passed.

And the question—That the new clause proposed to be inserted be so inserted—was put accordingly, and negatived.

Bill agreed to.

Bill to be reported without amendment.

The House resumed; Mr I. L. Robinson reported accordingly.

On the motion of Mr Viner (Minister Assisting the Treasurer), the House adopted the report.

Mr Viner asked leave to move—That the Bill be now read a third time.

Objection being raised, leave not granted.

Mr Viner, pursuant to contingent notice, moved—That so much of the standing orders be suspended as would prevent the remaining stages being passed without delay.
