5 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—MIGRANT SERVICES: Mr Speaker informed the House that Dr Cass had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The inadequacy of services for migrants particularly at a time of high unemployment".

The proposed discussion having received the necessary support—

Dr Cass addressed the House.

6 NATIONAL WATER RESOURCES (FINANCIAL ASSISTANCE) BILL 1978: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Keating who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the provisions of the Bill, the House is of the opinion that separate enactments should have been provided for each water resources project".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Message from the Governor-General: Message No. 1, dated 23 February 1978, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Newman (Minister for National Development), the Bill was read a third time.

We, the House of Representatives of the Commonwealth of Australia, in Parliament assembled, desire to express our loyalty to our Most Gracious Sovereign, and to thank Your Excellency for the Speech which you have been pleased to address to Parliament—

Debate resumed.

Debate adjourned (Mr Keating), and the resumption of the debate made an order of the day for the next sitting.

17 ADJOURNMENT: Mr Howard (Treasurer) moved—That the House do now adjourn. Debate ensued.

Question-put and passed.
