- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

 - Mr Bradfield, Dr Edwards, Mr Ellicott, Mr C. K. Jones and Mr McLean—from certain citizens praying for the prohibition of pornographic material involving children.
 - Mr Cairns, Mr Dobie, Mr Fife, Mr P. F. Johnson and Mr Ruddock—from certain citizens praying that no measures be taken to implement those recommendations of the Royal Commission on Human Relationships that will further undermine and weaken marriage, child-care or the family.
 - Mr Bourchier, Mr Fraser, Mr Lynch and Mr Stewart—from certain citizens praying that the Medical Benefits Schedule be amended to preclude payment of benefits for abortions.
 - Mr Bradfield and Dr Edwards—from certain citizens praying that a broadly representative Schools Commission be maintained to determine national priorities in education and other matters.
 - Dr Klugman and Mr J. L. McMahon—from certain citizens praying that proposed changes to Medibank not be implemented and that there be consultation with the trade unions and the community.
 - Dr Blewett—from certain citizens praying that the recent Budget increase in excise on spirits, especially brandy, be withdrawn to assist the South Australian wine and grape-growing industry.
 - Mr Calder—from certain citizens praying that permission be given for uranium mining in the Northern Territory to commence immediately.
 - Dr Everingham—from certain citizens praying that pensions be increased twice yearly in line with rises in the Consumer Price Index.
 - Mr L. R. Johnson—from certain citizens praying for the provision of funds for the construction and maintenance of an aged persons complex in the Electoral Division of Hughes.
 - Mr L. R. Johnson—from certain citizens praying for the replacement of the 1978-79 Budget by a budget which increases the level of economic activity, lowers unemployment, assists the disadvantaged and revives business and consumer confidence.
 - Mr C. K. Jones—from certain citizens of New South Wales praying that certain features of the Health Insurance Act be restored and that certain other action be taken in relation to health funding.

Mr J. L. McMahon—from certain employees of Colgate Palmolive Pty Ltd. Sydney, praying that Medibank be reinstated in its original form.

Mr Porter-from certain citizens praying for continued and increased Federal subsidies to maintain all existing South Australian country rail services.

7 MARALINGA NUCLEAR WASTE—MINISTERIAL STATEMENT—PAPER NOTED: Mr Killen (Minister for Defence), by leave, made a ministerial statement relating to the past burial of nuclear waste at Maralinga, S.A. and, by command of His Excellency the Governor-General, presented the following paper:

Maralinga nuclear waste—Ministerial statement, 11 October 1978.

Mr Staley (Minister for Post and Telecommunications) moved-That the House take note of the paper.

Suspension of standing orders—Extended time for speech: Mr Staley, by leave, moved— That so much of the standing orders be suspended as would prevent Mr Bowen (Deputy Leader of the Opposition) speaking for a period not exceeding 35 minutes. Question—put and passed.

- Mr Bowen moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "this House censures the Government for its incompetence and failure to adopt responsible nuclear policies and its misleading and contradictory statements about British atomic weapons tests and forthwith calls upon the Government to appoint an independent committee of inquiry to report upon—
 - (1) the disposal of plutonium and all other radioactive waste materials in Australia;
 - (2) the health of the Aboriginal population near the weapons test area in South Australia and the future environmental management of those areas, and
- (3) the need to establish a nuclear safeguards, safety and security commission". Debate continued.
