- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Peritions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Dobie, Mr Hyde, Mr Lusher, Sir William McMahon and Mr Viner—from certain citizens praying for the prohibition of pornographic material involving children.
 - Mr Cairns, Mr Humphreys and Mr Jull—from certain citizens praying that pensions be increased twice yearly in line with rises in the Consumer Price Index.
 - Mr Bourchier and Mr Short—from certain citizens praying that the Medical Benefits Schedule be amended to preclude payment of benefits for abortions.
 - Mr Dobie and Mr Jull—from certain citizens praying that no measures be taken to implement those recommendations of the Royal Commission on Human Relationships that will further undermine and weaken marriage, child-care or the family.
 - Mr Gillard and Sir William McMahon—from certain citizens praying for the rejection of any legislation introducing annual adjustments of pensions rates.
 - Mr Calder—from certain citizens praying that permission be given for uranium mining in the Northern Territory to commence immediately.
 - Dr Edwards—from certain citizens praying that a broadly representative Schools Commission be maintained to determine national priorities in education and other matters.
 - Mr Katter—from certain electors of the Division of Kennedy praying that sales tax be abolished and no new tax such as a value added tax be imposed.
 - Dr Klugman—from certain citizens praying that proposed changes to Medibank not be implemented and that there be consultation with the trade unions and the community.
 - Mr Lusher—from certain citizens praying for a halt in the automation of rural telephone exchanges pending a Parliamentary inquiry.
 - Mr Macphee—from certain citizens praying that a commitment be made to reduce unemployment progressively.
 - Mr Sainsbury—from certain citizens praying that funds be provided for the proposed Bega community youth support scheme program.
 - Mr Short—from certain citizens praying that Radio 3CR Melbourne be required to adhere to the broadcasting standards laid down for all other radio stations and that legislation be enacted against incitement to racial hatred and violence.
 - Mr Short—from certain citizens of Ballarat, Vic., praying that the circulation and sale of pornographic material be banned and a censorship board be established.
 - Mr Wallis—from certain citizens praying for continued and increased Federal subsidies to maintain all existing South Australian country rail services.
