- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Adermann, Mr Aldred, Mr Bourchier, Mr Carlton, Mr Cohen, Mr Gillard, Mr B. O. Jones, Mr Lynch, Mr Martin, Mr Sainsbury and Mr Willis—from certain citizens praying that pension payments be restored to twice-yearly adjustments and that pensions and unemployment benefits be raised to 30% of average weekly earnings.
 - Mr Baume, Mr Cohen, Mr Howard, Mr Innes, Mr Lynch, Mr Nixon and Mr Staley—from certain citizens praying for the appointment of an independent inquiry into the Australian Broadcasting Commission to investigate the qualifications of commissioners and certain other matters.
 - Mr Aldred, Mr Baume, Mr Chapman, Mr Jull and Mr Shipton—from certain citizens praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.
 - Mr Aldred—from certain citizens praying that the taxation law be amended to permit registered tax agents to trade for a full year and lodge income tax returns at the close of the respective tax year.
 - Dr Everingham—from certain citizens praying that major traditional Aboriginal land areas be resumed from the States eventually to become defined Aboriginal community co-operatives.
 - Dr Everingham—from certain citizens praying that action be taken to improve the retirement conditions of all sections of the Australian workforce that are not supported by superannuation or long service leave schemes.
 - Mr Jull—from certain citizens praying that a protest be sent to the Canadian Government objecting to the slaughter of Harp Seal pups.
 - Mr Simon—from certain students of Drouin High School, Vic., in similar terms to the last preceding petition.
 - Mr Lynch—from certain citizens praying that the imperial system of weights and measures be restored.
 - Mr Lynch—from certain electors of the Electoral Division of Flinders praying that pensions be adjusted at 6 monthly intervals.
 - Mr J. L. McMahon—from certain residents of Newtown, N.S.W., praying that the proposal of the Major Airport Needs of Sydney Study to construct a new runway at Kingsford-Smith Airport be rejected.
 - Mr Sainsbury—from certain citizens praying that the House reject the motion of the honourable Member for Hume concerning medical benefits for abortion and support abortion as a claimable item under all health benefits.
 - Mr Sainsbury—from certain citizens praying that increased funds be made available to New South Wales pre-schools.

Mr Short—from certain residents of Ballarat, Vic., praying that a ban be placed on the slaughter of seals.

Mr Willis—from certain electors of Victoria praying that compensation benefits paid to injured Commonwealth Government employees be increased and then adjusted automatically.

- 5 Australian Financial System—Committee of Inquiry: Mr Hurford, pursuant to notice, moved—That this House—
 - (1) welcomes the establishment of the Committee of Inquiry into the Australian Financial System on 18 January 1979, and notes that it follows the initiative in this matter by the honourable Member for Adelaide in the original notice for General Business Thursday No. 8 submitted by him to this House on 21 February 1978, and
 - (2) is of the opinion (a) that the membership of the Committee is too closely involved with the Capital market to provide a completely detached analysis of its imperfections and (b) that the terms of reference of the Committee (i) are couched in a way to justify claims of political overtones and (ii) give insufficient attention to the social welfare implications of the financial system, particularly its impact on the housing market.
